




Dear Pete:

Dear Mr. Porter:

Aztec Oil & Gas Company hereby submits its application for administrative approval for authority to construct a common tank battery at a location in the Southwest 1/4 of Northwest 1/4 of Section 3, Township 19 South, Range 37 East, Lea County, New Mexico, and commingle the production of oil from State of New Mexico oil and gas leases E-9122 and E-6424 insofar as they cover the Northwest 1/4 of Section 3, Township 19 South, Range 37 East.

In support of this application, Aztec states and shows the following:

1. The two State leases, E-9122 and E-6424, involved are dedicated to a common beneficiary, (i.e.; D.D.B.).

2. Aztec's State E-3 well, located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 3 is producing from the Queen formation and its east offset in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ is expected to be completed within the next few days in the same formation. Aztec agrees that the common tankage request will be used only for wells producing from a common source of supply, which in this instance will be the Queen formation. Permission requested in this application will apply only to the four units in the NW $\frac{1}{4}$ of Section 3, and adequate facilities will be provided for accurately determining the production from each well at reasonable intervals.

3. Attached are consents in duplicate from owners of adjoining oil and gas leases, consenting to the proposed commingling of oil from the separate State leases. There is also attached a

letter from the United States with respect to unleased Federal lands consenting to our proposal.

4. Also attached is a letter from the State Land Commissioner approving the commingling of oil from the State of New Mexico leases E-9122 and E-6424 subject to approval by the Oil Conservation Commission.

We respectfully request that you grant this application at the earliest possible date.






