

Dear Sir:

This letter is a request for temporary authority to use centralized tankage on our State "PA" and State "PB" Leases in the Pearl Queen Field.

We are currently developing acreage in the Pearl Queen Field including the two 80-acre State Leases: State "PA", (Shell NM 1558; New Mexico State E-5838), and State "PB", (Shell NM 1559; New Mexico State E-5839). Both of these leases are located in T-19-S, R-35-E, Section 27. One well has been completed on the State "PA" Lease, and one well now being drilled on the State "PB" Lease will be completed in about one more week.


We propose to use the tank battery located on the State "PA" Lease for production from both the State "PA" and State "PB" Leases. This existing battery is shown on the attached plat. The use of common tankage for these two leases would eliminate the cost (about \$7,000) of building a second tank battery on the State "PB" Lease.

All of the requirements for an exception to Rule 309 (a) have been met with the exception of requirement No. 4. The wells will be producing from a common source of supply, that being the Queen Formation. Permission has been obtained from the Office of the Commissioner of Public Lands to commingle production from several State Leases, including the two subject leases. Also, only four wells will be producing into the tank battery with full development of both leases, and adequate facilities will be provided for accurately determining production from each well at reasonable intervals. We are now in the process of notifying Cabot Carbon Company, the only offset operator to either of the subject leases, of our intent to use common tankage.

It will be impossible, however to obtain a waiver from Cabot Carbon Company and approval from the New Mexico Oil Conservation Commission in time for the completion of State "PB" No. 1. It is, therefore, requested that we be granted temporary authority to produce State "PB" No. 1 into the tank battery located on the State "PA" Lease until such time as permanent approval can be issued.

A reply on this matter at your earliest convenience will be appreciated.


