Gentlemen:

The Texas Company hereby requests permission under the provisions of Commission Rule 309-b to commingle oil in common storage and casinghead gas from separate state oil and gas leases and, in support thereof, submits the following:

1. State of New Mexico "BV" Lease comprises the W/2 of Section 26, T-13-S, R-33-E, and the State of New Mexico "BY" Lease consists of the N/2 of the NE/4 and the NW/4 of the NW/4 of Section 35, T-13-S, R-33-E, Lea County, New Mexico. (See attached plat.) The subject leases are dedicated to a common beneficiary, Common Schools.

2. State of New Mexico "BV" Lease currently has five producing wells in the Lazy "J" (Pennsylvanian) Pool, and the State of New Mexico "BY" Lease has one producing well in the Lazy "J" (Pennsylvanian) Pool. Thus, all of the wells involved in this application are producing from a common source of supply.

3. A total of six units will produce into the proposed common tank battery, and not more than eight units will be produced into the proposed battery without first obtaining Commission approval of such procedure. The primary purpose of this consolidation is to provide common storage, treating, and pumping facilities for a subsurface hydraulic pumping installation which will be installed in the near future. As a part of this installation, adequate facilities will be provided for accurately determining production from each well at reasonable intervals.

4. The State Land Office has given its approval to the proposed commingling as indicated by the attached photostatic copy of a letter from Mr. Murray E. Morgan, Commissioner of Public Lands.

5. By copy of this letter of application, all of the operators of acreage offsetting the State of New Mexico "BV" and "BY" Leases have been notified by registered mail of The Texas Company's intent to commingle production of oil and casinghead gas from these two leases.

In view of the foregoing facts, The Texas Company respectfully requests that it be given administrative approval by the Secretary-Director of the Commission to commingle oil from its State of New Mexico "BV" and State of New Mexico "BY" Leases in common storage on its State of New Mexico "BV" Lease and to commingle casinghead gas production from these two leases as it leaves a common separator on the State of New Mexico "BV" Lease.
