Gentlemen:

We ask your approval of exception to Rule 309-B affecting production into a central tank battery on Roberson Lease (SF 078391) and Roberson "A" Lease (SF 078391-A) located in Sections 24, 25 and 36, Township 27 North, Range 13 West, N.M.P.M., San Juan County, New Mexico. We propose to do this in the following manner:

1. The production from the individual leases will come into the tank battery through individual production manifolds.
2. The production from the Roberson Lease will flow through a separator and then into a storage tank where the production can be gauged.
3. Production of the Roberson A Lease will be pumped *into a separator* ~~directly into production manifold~~ and then into a separate storage tank where the production can be gauged.
4. Two extra storage tanks will be used to produce into in the event the tank for the Roberson or the tank for the Roberson A Lease becomes full; but in no event will both ~~leases be produced into the same tank at the same time.~~ *Just*
All rules of the New Mexico Conservation Commission, particularly those regarding allocation of production and limitation of wells which may be produced into a common tank battery, will be observed.

Attached is a schematic diagram of the proposed tank battery which is correct, ~~except for the fact that the separator will not be~~

We direct your attention to the fact that a similar installation for adjoining leases Hanson and Hanson 'B', were recently approved for the El Paso Natural Gas Products Company.

For your information, the Roberson Lease consists of the NE/4 of Section 24, the NE/4 of Section 25 and the NE/4 of Section 36, Township 27 North, Range 13 West. The Roberson 'A' Lease consists of the SE/4 of Section 24, the SE/4 of Section 25 and the SE/4 of Section 36, Township 27 North, Range 13 West. Location of the existing Roberson tank battery is 2640 feet from the North and East lines of Section 36, Township 27 North, Range 13 West. All wells on the two leases are producing from the Gallegos-Gallup pool and any future wells to be produced into the tank battery will be producing from the Gallegos-Gallup pool. This installation has been approved by the United States Geological Survey.

Anything you can do to expedite approval of this application will be appreciated.



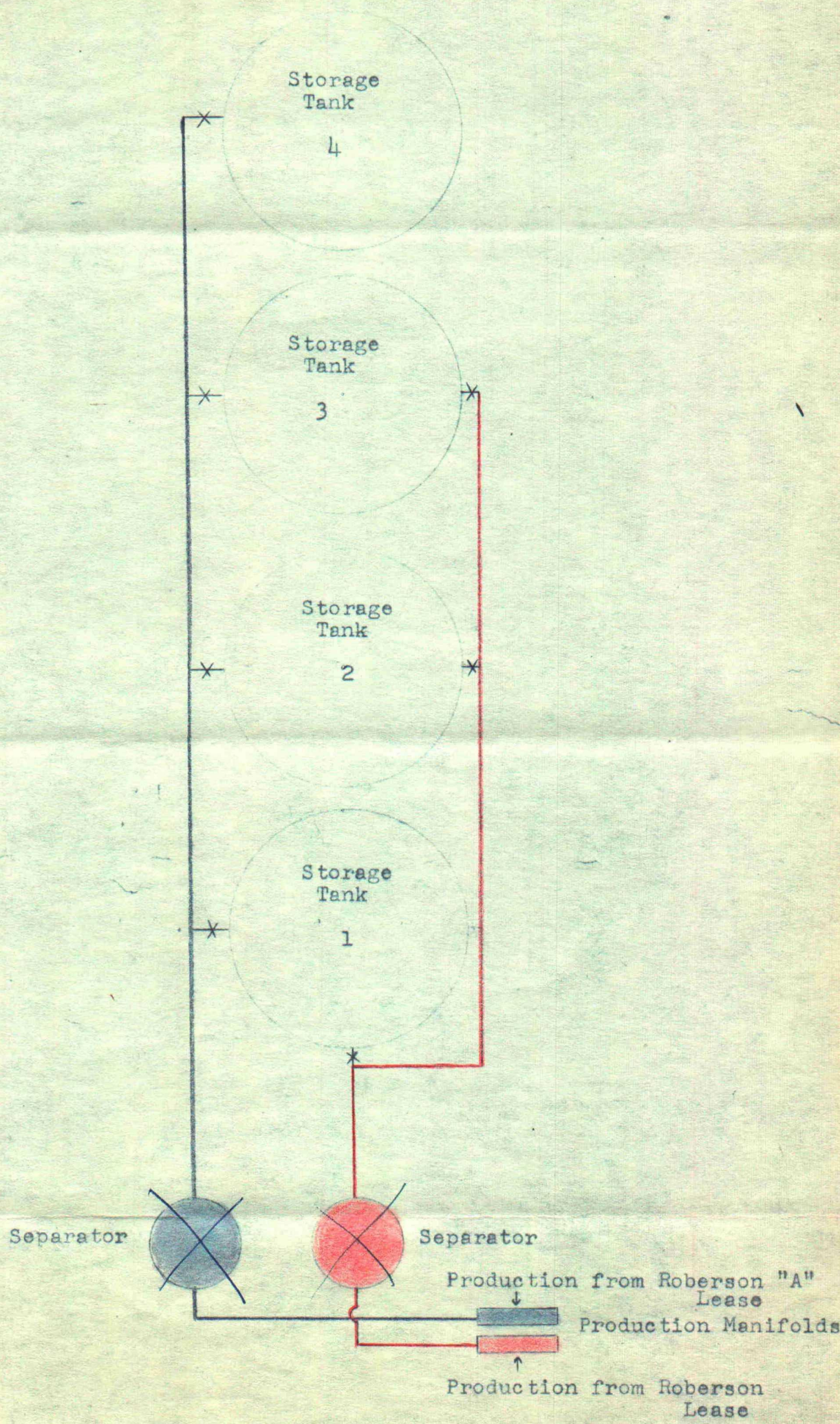
