Gentlemen:

TEXACO Inc. was granted administrative approval of an exception to Rule 309 (a) by Order CTB No. 40 dated May 27, 1959 to commingle production from the Saunders Pool for the State of New Mexico "AN" Lease, comprising all of Section 22, "AT" Lease, comprising all of Section 15 and the "BG" Lease, comprising all of Section 14. This order was amended May 11, 1962 to include the State of New Mexico "BG" NCT-2 (B-9560) Lease. Inadvertently this lease was described as being the NW/4 of Section 16, T-14-S, R-33-E, Lea County, New Mexico. The correct description of this lease is the NE/4 of Section 16, T-14-S, R-33-E.

TEXACO Inc. respectfully requests an amendment of Administrative Order CTB No. 40 to correct the description of the "BG" NCT-2 Lease from NW/4 to NE/4 of Section 16 and to include the S/2 of S/2 of Section 10, T-14-S, R-33-E, which is part of the "AT" (B-9505) Lease, that was not included in the original application.

Attached is a diagramatic sketch of the commingling installation along with a plat indicating the present and proposed commingled area.

In accordance with Rule 309 (b) TEXACO Inc. respectfully requests an exception to Rule 309 (a) as noted above.


