TEXACO Inc. desires to commingle the crude production from our State of New Mexico "AS" NCT-1 and "BT" NCT-1 Leases, Tulk Wolfcamp Pool, in common storage facilities located on the State "AS" NCT-1 Lease. The "AS" NCT-1 Lease is comprised of the NE/4 of Section 6 and the NW/4 NW/4 of Section 5, T-15-S, R-32-E, and the "BT" NCT-1 Lease is the E/2 SE/4 of Section 6, T-15-S, R-32-E, Lea County, New Mexico. The production to be commingled is from a common reservoir; the working and royalty interests are common and the leases are contiguous as shown on the attached plat. There is one producing well on the "BT" NCT-1 Lease and three producing wells on the "AS" NCT-1 Lease. One well on the "AS" NCT-1 Lease, Well No. 3, is non-commercial and is to be plugged and abandoned and plans are to transfer the hydraulic pumping equipment from this well to the "BT" NCT-1 well replacing the high operating cost conventional rod pumping installation currently installed, thus prolonging the commercial producing life of the "BT" well. Adequate testing facilities are available on the "AS" NCT-1 Lease for testing each well periodically.

TEXACO Inc. hereby makes application for administrative approval of the proposed commingling operations described above in accordance with Rule 309 (b). Consent in writing has been obtained from the common royalty owner as shown by the attached letter, and TEXACO Inc. is the only working




