Gentlemen:

Ralph Lowe has filed an Application to Drill a Devonian test well, to be called No. 1 Mescalero State "A", at a location 330 feet from the South line and 330 feet from the East line of NE/4 of NW/4 of Section 27, T-10-S, R-32-E, Mescalero Field, Lea County, New Mexico. ✓

In accordance with Rule No. 309, if this well is capable of producing oil in the Devonian formation, we wish to comingling the production from this lease with the production from Ralph Lowe-✓ State Lease OG-5545. This request for comingling comes within the provisions as set out in Rule No. 309 as amended, Subparagraphs B-1, B-2, B-3 and B-4. Under B-5, we had inquired of the State Land Office, prior to purchase of this oil and gas lease, and found that the beneficiary of the State royalty is common under both tracts and verbally they have tentatively approved our request for comingling, subject of course, to your final disposition.

To conform to Subparagraph B-6, we are notifying, by registered copy of this letter, all owners of the adjoining oil and gas leases.
