Dear Sir:

The Pure Oil Company as operator of the Reeves and Reeves "A" Leases in The South Vacuum Devonian Pool, Lea County, New Mexico, hereby makes application to The New Mexico Oil and Gas Commission for permission to commingle Devonian production from these two leases.

Adequate facilities will be provided for conducting well tests at appropriate intervals. The attached schematic illustrates the proposed tank battery hookup after commingling and shows that testing can be done by either routing a well through the test separator or the treater. It is requested that quarterly well tests be approved for lease prorating purposes.

All parties owning an interest in the leases, including royalty owners and working interest owners, have consented in writing to the commingling of Devonian production. Attached are copies of these approvals.


It is requested that the requirement to separately measure production from each lease before commingling be waived. The ownership of the leases is common throughout, and production from only one zone is involved.



WHEREAS, an oil and gas lease dated April 9, 1957, recorded in Volume 154 at page 131 of the Deed Records of Lea County, New Mexico, was executed by A. J. Reeves and wife, Izella C. Reeves, and Janie P. Reeves, as Lessor, to Donald E. Blackmar, as Lessee, covering the West Half of the Southeast Quarter (W/2 of SE/4) and the Northeast Quarter of the Southwest Quarter (NE/4 of SW/4) of Section 26, T-18-S, R-35-E, N.M.P.M., Lea County, New Mexico, only from and below 7,000 feet below the surface, and reference to said lease and the record thereof is here made for all purposes; and

WHEREAS, an oil and gas lease dated April 9, 1957, recorded in Volume 154 at page 123 of the Deed Records of Lea County, New Mexico, was executed by D. P. Reeves and wife, Elva Nelle Reeves, as Lessor, to said Donald E. Blackmar, as Lessee, covering the Southeast Quarter of the Southwest Quarter (SE/4 of SW/4) of Section 26, T-18-S, R-35-E, N.M.P.M., Lea County, New Mexico, only from and below 7,000 feet below the surface, and reference to said lease and the record thereof is here made for all purposes; and

WHEREAS, there are producing oil wells located on the land covered by each of the above-identified leases, which wells are operated by The Pure Oil Company for itself and the other parties owning an interest in the leasehold estate; and

WHEREAS, the undersigned are the owners of the royalties and all other interests reserved to the Lessors under the terms of the foregoing oil and gas leases and it is the desire of both

the undersigned and the owners of the working interest and operating rights under said leases that a common tank battery be used to serve both leases;

NOW THEREFORE in consideration of the premises and other valuable consideration, the receipt and sufficiency of which is acknowledged by the undersigned, the undersigned hereby agree that The Pure Oil Company, as Operator of both of the leases identified above, may establish a common tank battery at a location of its choice on the above-described 160 acres of land, more or less, comprising the East Half of the Southwest Quarter (E/2 of SW/4) and the West Half of the Southeast Quarter (W/2 of SE/4) of said Section 26, T-18-S, R-35-E, N.M.P.M., Lea County, New Mexico, and that said common tank battery may be used to serve both of the above-described leases, thus allowing the production of oil from both of said leases into said common tank battery and the commingling of the oil produced from both leases in said common tank battery. The undersigned further agree that settlement with the royalty owners for production from both of the above-identified leases may be made upon a single division order.

Except as above provided, said leases shall be in no way amended or modified.

This agreement shall be binding upon the undersigned, their heirs, successors and assigns, and shall inure to the benefit of The Pure Oil Company and the other owners of the mineral leasehold estates created by said leases, and the successors and assigns of each.
