Gentlemen:

Cities Service Petroleum Company respectfully requests that the New Mexico Oil Conservation Commission grant administrative approval for exception to Rule 309-A whereby production from our State "BL" Lease and the Lane Lease can be commingled. Both of the above leases are located in the Mescalero (San Andres) Pool in Section 14-T10S-R32E, Lea County, New Mexico.

The following information is given in support of this application.

- (i). All production from the State "BL" and the Lane Leases are from the San Andres formation.
- (2). Adequate facilities will be provided for accurately determining production from each well at reasonable intervals.
- (3). All parties owning an interest in the leases and the purchaser of the commingled production therefrom have been notified by registered mail of the intent to commingling of production from the separate leases. A list of all parties owning and interest to whom registered mail was sent is attached.
- (4). Production from each of the aforementioned leases will be accurately measured and determined prior to commingling in accordance with the provisions as set forth in the Commission's "Manual for the Installation and Operation of Commingling Facilities".


