Permission is hereby granted to commingle the production from the Premier Sand from State Leases Nos. B2071 and B7966 in accordance with your application. The SE $\frac{1}{4}$ SW $\frac{1}{4}$ and W $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 31, Township 17S, Range 28E, is Common School lands; however, since this production is coming from two leases, it will be necessary that periodic tests on the wells be made in order to be sure that production is maintained.

Gentlemen:

In January, 1963, McWood Corporation began to purchase production from the Franklin Aston & Fair, Inc. State "AG" Lease, our number 352-12806, production unit number 10423, State Lease number B-2071. Pursuant to our telephone conversation of yesterday, I again contacted McWood Corporation and was advised by Mr. R. L. McPherson of McWood that he had advised you that McWood had no objection to the commingling of production from the leases in question.

P with the Oil Conservation Commission and a copy of the Application is enclosed herewith for your information.

Y The plat attached to the Application reflects that the lands are contiguous and the location of the proposed tank battery which is to be in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 31. It is my understanding that the lands all have a common beneficiary, being the Common Schools. Pursuant to a prior request, the Commissioner, by letter dated March 9, 1960, granted permission to Franklin, Aston & Fair, Inc. to commingle production from the above leases insofar as they cover the above described lands with production from lease B-11594 covering lands in Section 6, Township 18 South, Range 28 East. The operator proposes to commingle production from the two leases described above insofar as they cover the above described lands.

APPLICATION

Comes now Franklin, Aston & Fair, Inc. and hereby makes application for permission to commingle production of oil produced from two separate State Oil and Gas Leases covering the following described lands in the Red Lake (Grayburg-San Andres) Pool in Eddy County, New Mexico, to-wit:

$W\frac{1}{2}SE\frac{1}{4}$ and $SE\frac{1}{4}SW\frac{1}{4}$ Section 31, Township 17 South,
Range 28 East.

1. That the above described land is covered by two separate State Oil and Gas Leases and the lease numbers, record owners and the lands embraced in the respective leases are as follows:

B-7966	Bert Aston	$SE\frac{1}{4}SW\frac{1}{4}$ Sec. 31, T.17 S., R. 28 E.
B-2071	Bert Aston and Fair Oil Company	$W\frac{1}{2}SE\frac{1}{4}$ Sec. 31, T.17 S., R. 28 E.

That the above described leases insofar as they cover the above described lands are subject to an operating agreement, dated August 26, 1959, made and entered into by and between Franklin, Aston & Fair, Inc.; Bert Aston and Esther Aston, his wife; R.W. Fair and Pan American Petroleum Corporation and that Franklin, Aston & Fair, Inc. is the operator under the terms and provisions of the operating agreement. The parties to the operating agreement are the owners of all the working interest under the above described leases insofar as they cover the above described land with the exception of Fair Oil Company which has succeeded to the interest formerly owned by R.W. Fair.

2. That all of the parties owning the working interest and overriding royalty interests as well as McWood Corporation, the purchaser of the production, have orally consented to the commingling of production from the separate leases and are transmitting their respective consents to the commingling in writing direct to the Commission.

3. That all of the parties owning an interest in the leases and production therefrom have heretofore consented to the commingling of production from said leases in case No. 1839; and by Order No. R-1573 entered on January 6, 1960, the Commission permitted the commingling of Empire - Abo Pool production from the above leases and Lease No. B-11594 into a common tank battery.

4. That applicant and the other working interest owners have completed their State AG Well No. 1 located 1650 feet from the South line and 2310 feet from the East line of Section 31, Township 17 South, Range 28 East (NW $\frac{1}{4}$ SE $\frac{1}{4}$) to a total depth of 1951 feet in the Premier formation and are in the process of completing their AD Well No. 1 located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 31, Township 17 South, Range 28 East, and propose to develop the remaining portion of the above described land immediately.

5. That applicant proposes to commingle production from the Premier formation underlying the above described lands by producing the same into a centralized tank battery to be located on the SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31, Township 17 South, Range 28 East. A plat showing the location of the wells, tank battery and of the leases in question is attached hereto and marked "Exhibit A".

6. That adequate facilities will be provided to accurately determine the production from each well at reasonable intervals.

7. That there is a common ownership of all of the lands embraced in the leases described above and that there is a common beneficiary of the State Lease lands and that all of the lands are Common School lands. That the Commissioner of Public Lands has heretofore consented to the commingling of production from the above lands in Case. No. 1839.

8. That the commingling of production of oil from the wells on the two leases into a centralized tank battery will effect a considerable saving in installation and operating expenses and will be in the interest of conservation and will not cause waste or impair correlative rights.

WHEREFORE, the applicant requests that the Secretary-Director of the Commission grant an exception to Rule 309-A and that the applicant be granted permission to commingle production from the above described leases into one centralized storage facility.

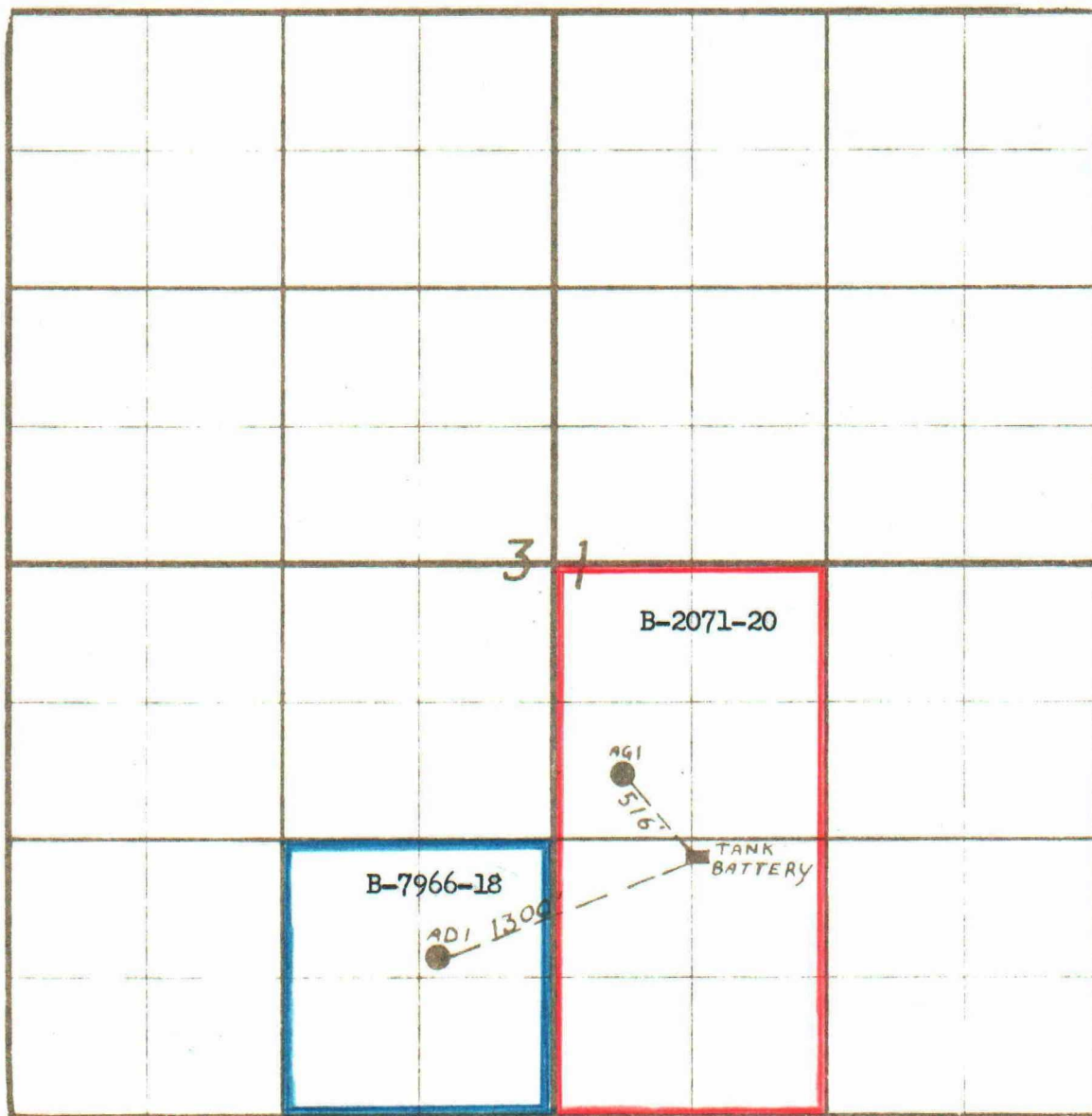
