This has reference to Administrative Order CTB-123 dated September 24, 1964, granted in response to our application dated September 11, 1964 for Administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of oil produced from the Tocito Dome-Pennsylvanian "D" Pool on our Navajo Tribal "N", "P", and "U" leases, San Juan County, New Mexico. Administrative Order CTB-123 authorized the commingling of production from the Navajo Tribal "N" and "U" leases and further stated that the Order would be amended to include the Navajo Tribal "P" lease at such time as production is obtained thereon.

Pan American Petroleum Corporation completed Navajo Tribal "P" No. 2 at a location in the NW/4 SE/4 of Section 7, T-26-N, R-18-W, in the Tocito Dome-Pennsylvanian "D" Pool on January 8, 1965. It is now our desire to commingle production from this well into the consolidated tank battery approved by Administrative Order CTB-123. It is therefore respectfully requested that said Order be amended to include the Navajo Tribal "P" lease.

Gentlemen:

Reference is made to your application dated September 11, 1964, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of oil produced from the Tostito Luna Leaseholdings "F" Pool on your Navajo Tribal "F", "G", and "H" Leases in Sections 7, 19, and 21, Township 26 North, Range 18 East, San Juan County, New Mexico. It is our understanding that each of these leases has a common working interest and that the royalty interest is common throughout also, and that you therefore propose to allocate the production to each of the leases on the basis of periodic well tests.

Under the authority granted us pursuant to Rule 309-B, you are hereby authorized to commingle the production from the aforesaid Navajo Tribal "F" and Navajo Tribal "G" Leases as proposed, subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities." This order will be amended to include the Navajo Tribal "H" Lease at such time as production is obtained thereon.
