Humble Oil & Refining Company requests administrative approval to commingle oil production from the Tobac Pennsylvanian Pool on our New Mexico State "BW" Lease, New Mexico State Lease No. E-9089, located in the SE/4 of Section 16, T-8-S, R-33-E, with oil production from the Tobac Pennsylvanian Pool on our New Mexico State "BX" Lease, New Mexico State Lease No. K-4495, located in the SW/4 and N/2 of Section 16, T-8-S, R-33-E, Chaves County, New Mexico.

Beneficiary for land in Section 16 is Common Schools. It is requested that the New Mexico State "BW" and "BX" Leases be allowed to produce into common storage with each well prorated on the basis of well tests.

We are enclosing approval of the Commissioner of Public Lands and the crude oil purchaser, The Permian Corporation.

The attached plat shows the location of the present tank battery, producing wells and well now being drilled.

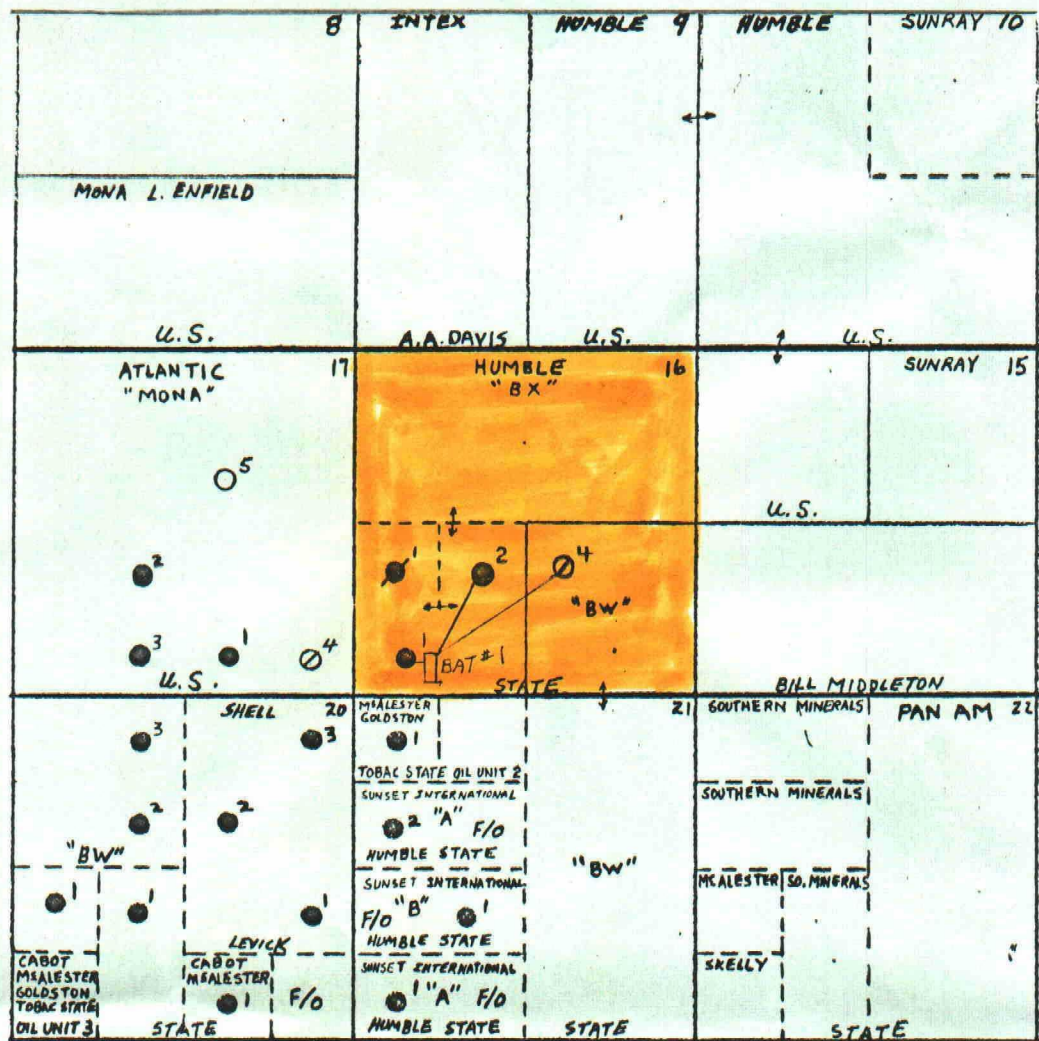

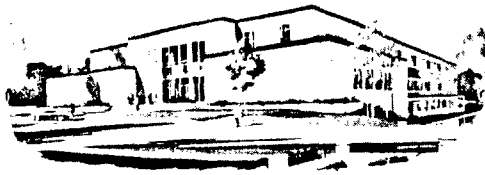

Gentlemen:

This letter supersedes our letter of today, in which we had rejected your proposed request. However, after your telephone conversation with Mr. Ray Graham of our office, we have come up with this proposal:

We hereby grant permission to commingle production from Bough "C" on State BW and State BX in as far as Section 16 is concerned. We would require that you send us a monthly report on each well as per production and gravity.


Should you ever wish to commingle production from Section 21, then we would ask for separate metering.

This is granted with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval should a loss of revenue occur to the State through this installation.

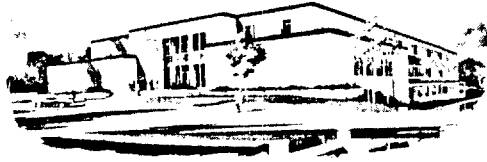
