Further, that although the leases do not have identical ownership throughout, they are covered by a commingling agreement executed by all parties owning an interest in the leases. Further, that the regional supervisor of the United States Geological Survey has approved the application to commingle.

under the authority granted me pursuant to Rule 309-B, you are hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission's "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters. You are further requested to notify the Artesia District Office of the Commission at such time as the installation is complete in order that a field inspection may be made of the installation prior to putting it in operation.
