Dear Mr. Porter:

Humble Oil & Refining Company requests Administrative approval to commingle Chaverco San Andres Undesignated oil production from its New Mexico "BW" State and New Mexico "BX" State Lease, Chaverco San Andres Undesignated Pool. Reason for this application is to eliminate one tank battery and costs involved.

The New Mexico "BX" State (New Mexico State Lease No. K-4495) Lease includes SW/4 and the N/2 of Section 16, T-8-S, R-33-E, Chaves County, New Mexico, and presently has one Chaverco San Andres Undesignated producing well. The New Mexico "BW" State (New Mexico State Lease No. E-9089) Lease includes only that portion in the SE/4 of Section 16, T-8-S, R-33-E, and presently has one producing well.

Beneficiary for land in Section 16 is Common Schools.

There will be no monetary gain or loss by commingling.


We are enclosing approval of the State Land Commissioner and the crude oil purchaser, Mobil Oil Company.

Schematic diagram of the entire system shows that production from each lease will be metered separately as required, with separate testing facilities.

The attached plat shows the location of the present tank battery, and the producing wells.

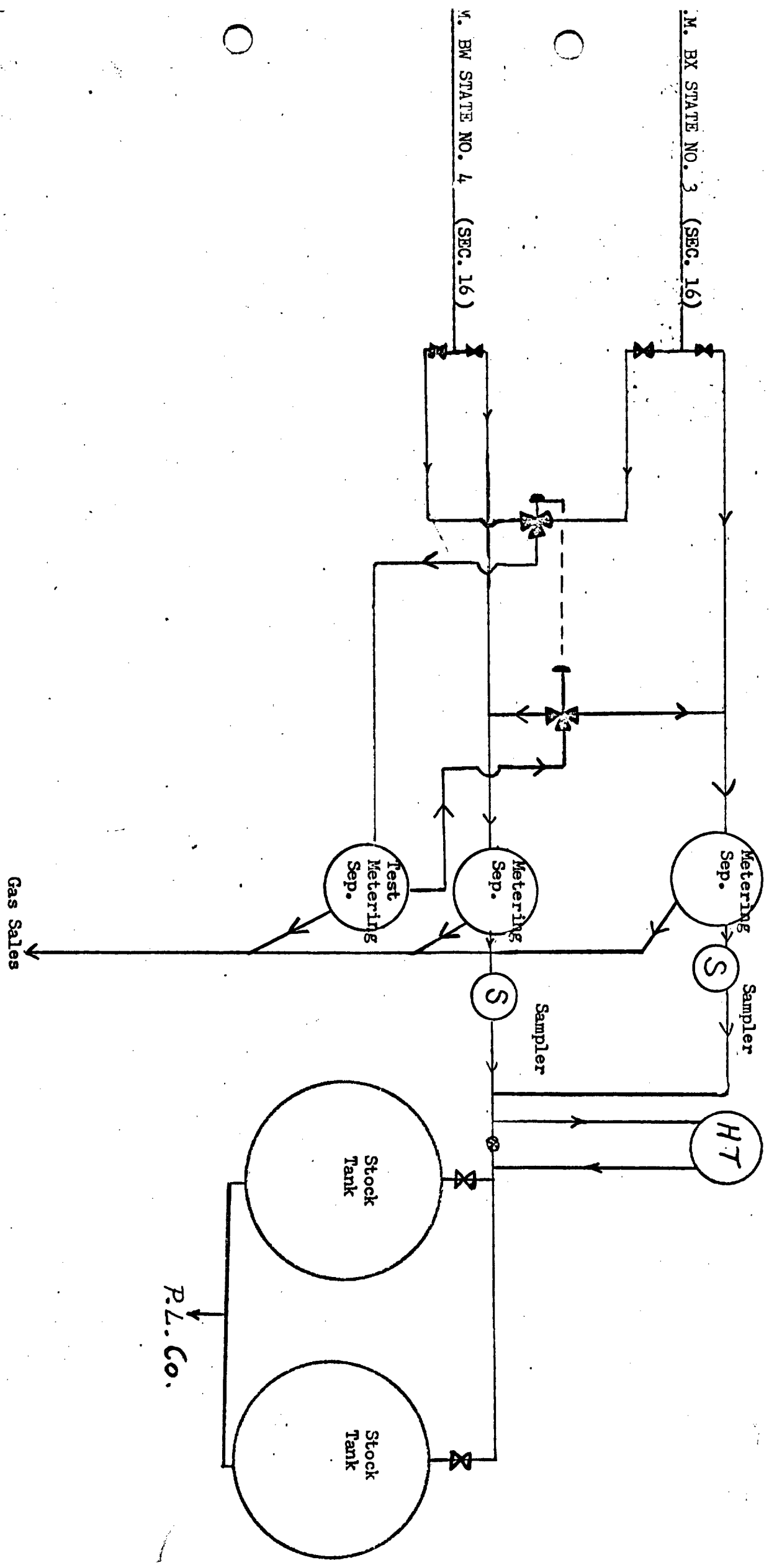

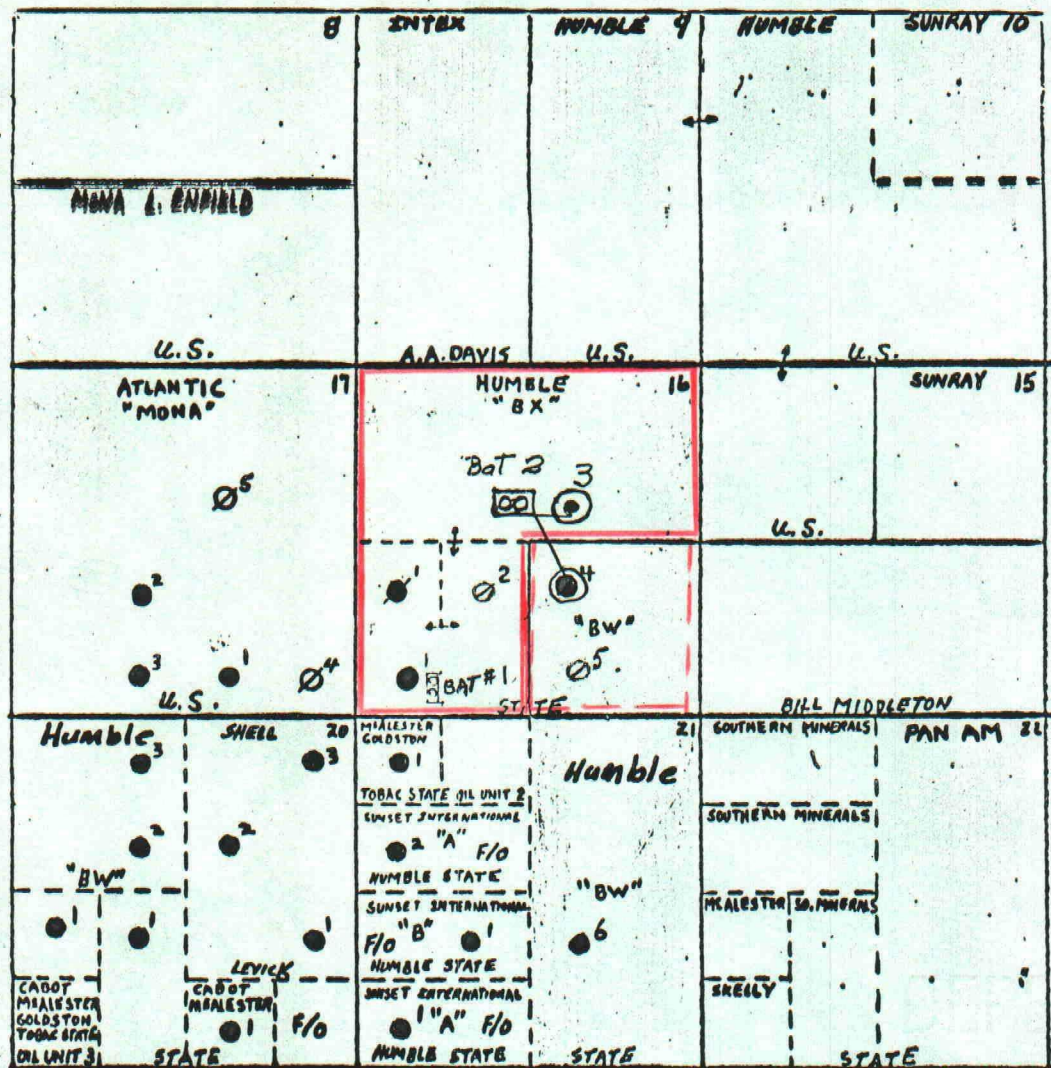
SCHEMATIC OF PROPOSED COMMINGLING FACILITIES,
