

Gentlemen:

Reference is made to your application dated August 26, 1968, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Vacuum Grayburg-San Andres production from your State J Lease comprising the NE/4 and N/2 SE/4 of Section 22, Township 17 South, Range 34 East and Vacuum Grayburg-San Andres production from that portion of your Bridges State Lease comprising the S/2 of Section 11, S/2 and NE/4 of Section 12, N/2 and SW/4 of Section 13, all of Section 14, E/2 of Section 15, and the N/2 and SE/4 of Section 23, all in Township 17 South, Range 34 East, Lea County, New Mexico. It is our understanding that the ownership of these leases is identical throughout and that you therefore propose to commingle said production allocating same to each lease on the basis of monthly well tests.

We have now received the consent of the State Land Office to the proposed commingling.

Under the authority granted me pursuant to Rule 309-B, you are hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities."
