Lease: Eagle '34' Federal (Federal Lease No.LC-064050-A)
Description: E/2 NW/4, NE/4 SE/4 of Section 34,

Lease: Eagle '35' Federal (Federal Lease No.LC-064050-A)
Description: NW/4 SW/4 of Section 35, and

Production shall be allocated to each lease by separately metering the production from each lease prior to commingling.


NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled production shall be stored in the Eagle Federal tank battery facility located in Unit Letter 'K' of Section 34, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.
