We have received your letter of October 8, 1997, wherein you requested our approval for surface commingling, off-lease storage and measurement of the Poker Lake production for the above-captioned wells into an existing tank battery (Commingling Order No. CTB 462).

It is our understanding that production from the Poker Lake Unit Well Nos. 79 and 91 will be metered separately prior to being commingled at the tank battery.

Since it appears that there will be no loss of revenue to the State of New Mexico's beneficiaries as a result of your proposed operation, your request is hereby approved. Our approval is given with the understanding that the Commissioner of Public Lands reserves the right to amend or withdraw his approval, should this operation prove to be unprofitable to the state at any time in the future. Also, our approval is subject to like approval by the New Mexico Oil Conservation Division and the Bureau of Land Management.




We have received a copy of the New Mexico Oil Conservation Division's Order #CTB-462 which notifies this office of your application to surface commingle the production from the above-captioned wells.
