COMMINGLING ORDER PC-33

Description: S/2 Section 10, W/2 SW/4 of Section 11, W/2 E/2, W/2 of Section 15,
Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.

The above-named company is hereby authorized to commingle **Eumont-Yates Seven Rivers Queen Prorated Gas (76480), Eunice Monument-Grayburg San Andres (23000), Southeast Monument-Abo (96764), Monument-Paddock (47080), Monument-Tubb (47090), Skaggs-Abo Gas (85410), Weir-Blinbry (63780), East Weir-Blinbry (63800) and Weir-Drinkard (63840)** and Pool production in a common tank battery and to determine the production from each well by well tests. This method is authorized only so long as all commingled production is of marginal nature; further the operator shall notify the Santa Fe office of the Division in the event any well on the commingled battery becomes capable of top allowable production, at which time the Division will amend this order or take such other action as may be appropriate. All commingled production must be of identical ownership including working interest, royalty interest and overriding royalty interest.

FURTHER: The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process.

REMARKS: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: Wells No. 20, 22 and 28 are downhole commingled as authorized by Division Orders DHC-5, DHC-1894 and DHC-2190.

NOTE: Commingled production shall be stored in the Britt B tank battery facility located in Unit E, Section 15, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.

PROVIDING: Validation of this authority shall be accomplished by like approval from the U.S. Bureau of Land Management.
