

We hereby request administrative approval to commingle production from the Blinebry and ABO formations at the surface on the Carter 19-#1 and #2 lease. The gravity of the Blinebry Oil is 37.4 and the ABO is 37.2. We currently receive the same price for both zones, and combined gravity should be 37.3. The lease is currently producing 50 BOPD, 25 BO from the #1 Well (Blinebry) and 25 BOPD from the #2 Well (ABO). A well location plat and schematic diagram of the tank battery is attached. The value of the commingled oil will be the same as it currently is. The use of a single tank battery will be more efficient due to less gas used at lease burning heater treators and fewer tanks that would be needed.
