Burlington Resources Oil & Gas Company respectfully requests to amend Commingling Order PLC-98. Due to the forming of the East Corbin Delaware Unit, the Bureau of Land Management segregated federal lease numbers thusly, causing this amendment. Also, production from the Tijeras State Lease has been commingled with production from the other leases and not just off-lease storage as originally indicated. This involves production from the South Corbin Wolfcamp pool.
