Lease: Elvis Well Nos.1 and 4 (Federal Lease No.LC-029405-A)  
Description: N/2 of Section 20, and,

Lease: Elvis Well No.2 (Federal Lease No.LC-029405-B)  
Description: W/2, W/2 NE/4, W/2 SE/4 of Section 17, and,

Lease: Elvis Well No.3 (Federal Lease No.LC-060329)  
Description: E/2 NE/4, E/2 SE/4 of Section 17,

all in Township 17 South, Range 32 East, NMPM, Lea County, New Mexico.

Production shall be allocated to each lease by separately metering the production from each well prior to commingling


FURTHER: The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process.

REMARKS: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

NOTE: The commingled production shall be stored in the Elvis Consolidated tank battery facility located in Unit Letter 'F' of Section 20, Township 17 South, Range 32 East, NMPM, Lea County, New Mexico.

NOTE: Validation of this authority shall be accomplished with like approval by the U.S. Bureau of Land Management.

Dear Mr. LeMay:

Conoco Inc. requests approval for off-lease storage and surface commingling of Devonian and Strawn production from its Elvis Wells No. 1, 2, 3, and 4, located on three different federal leases. These wells, leases, and producing zones are identified on the map in Exhibit 1.

The Elvis No. 1 was the recent discovery well for a new Devonian pool, the Maljamar Devonian, West Pool. Wells No. 2 and 3 will further develop this new pool and No. 2 is currently drilling. Exhibit 1 shows that all three of these wells are located on three separate leases.


Well No. 4 will be drilled as a twin to No. 1 to develop highly prospective Strawn pay that was identified on the logs of No. 1. A battery facility is being constructed near Well No. 1 to handle the production from these four wells, three leases, and two pools and any further development that may occur, in order to minimize operational costs and maximize revenue for all interest and royalty owners.

The attached Exhibit 2 contains anticipated producing rates, oil gravities, and revenues from these wells and illustrates that no revenue is expected to be lost from the sale of commingled fluids. Exhibit 3 is a facility diagram of the proposed battery and show that each well and pool production will be metered separately before commingled in common storage.

Exhibit 4 is a list of the interest owners in all three leases identifying type of interest, name and address of owner, and the percent interest. Each of these parties were notified by certified mail of this application and their right to object to its approval. Copies of the certified mail receipts are included as Exhibit 5. Note that notification of the long list of Taubman Trusts was accomplished by notification of the agent, Everett D. Moran, who administers these trusts.

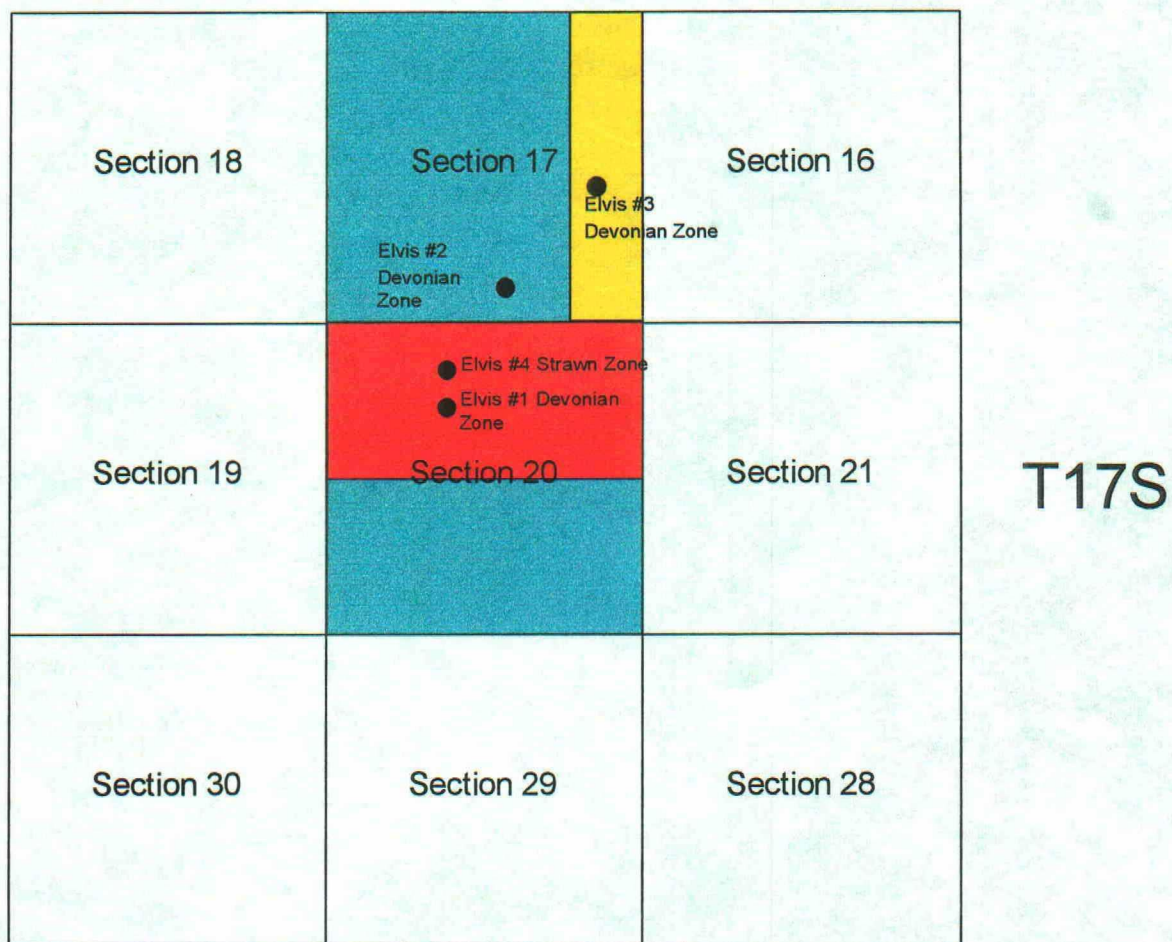

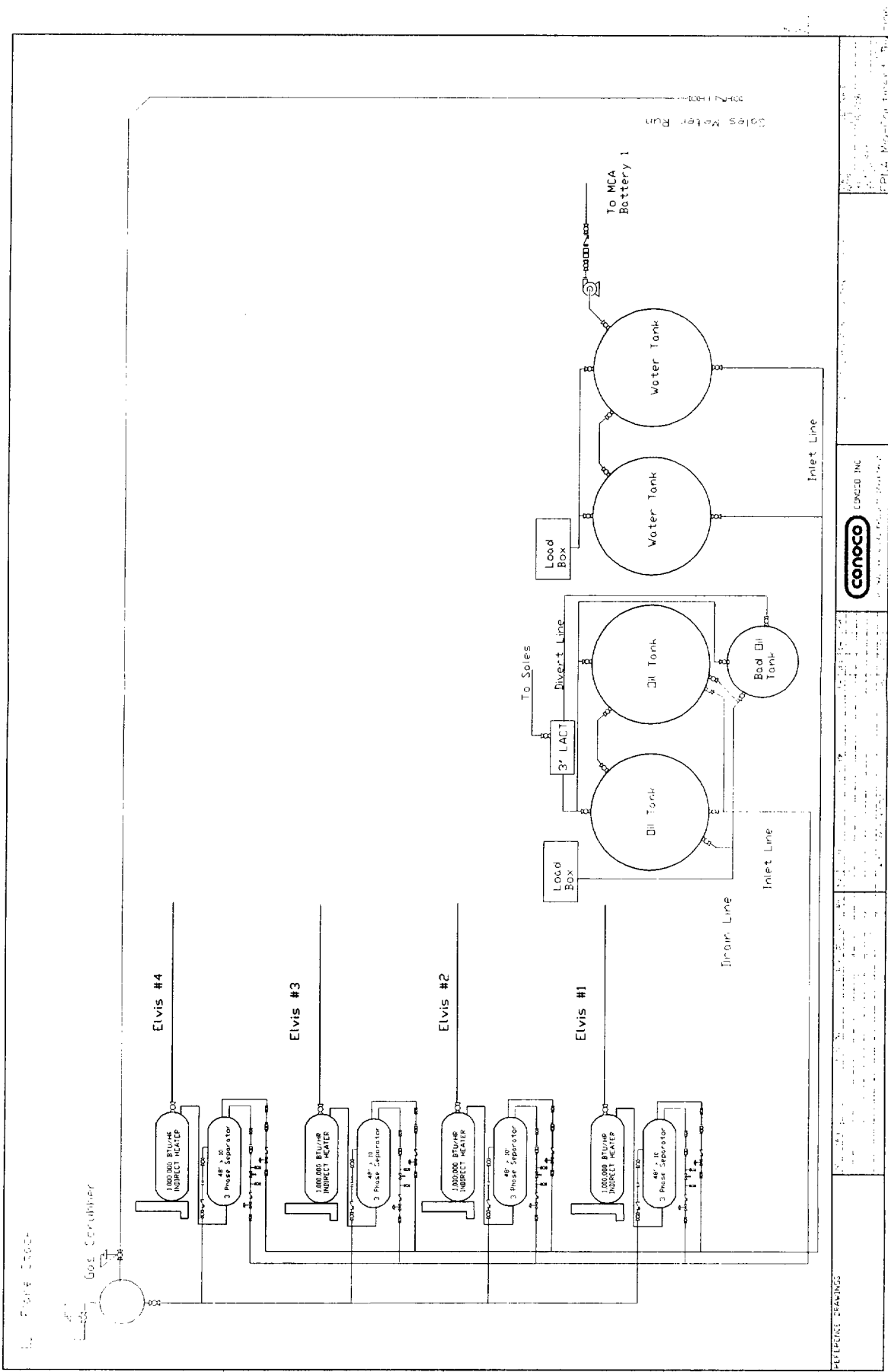
