This is to confirm our telephone conversation of yesterday regarding Administrative Order WFX-138 covering the expansion of the waterflood project area in the South Caprock Queen Unit in Chaves County.

An error in the requested location for a new water injection well (Tract 6, Well 9-17) was made in our original application for expansion dated May 10, 1963. We would like to request that the location of this well be changed as follows:

Tract 6, Well 9-17

Old Location (In Error):

- 1980' From the South Line and 1300' From the East Line, Section 17, T-15-S, R-31-E, NMPPM (Chaves County)

New Location (Correction of Above Location):

2310' From the South Line and 1300' From the East Line, Section 17, T-15-S, R-31-E, NMPPM (Chaves County)
