ORDER WFX NO. 240

ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Anadarko Production Company has made application to the Commission on August 12, 1966, for permission to expand its Pearsall Queen Sand Unit Water Flood Project in the Pearsall-Queen Pool, Lea County, New Mexico.

NOW, on this 30th day of September, 1966, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That waivers of objection have been received from offset operators.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, Anadarko Production Company, be and the same is hereby authorized to inject water into the Queen formation through the following described well for purposes of secondary recovery, to wit:

Federal - Love Well No. 1 located in the NE/4 SW/4 of Section 4, Township 18 South, Range 32 East, NMPM.

PROVIDED HOWEVER, That applicant shall inject water through tubing with a packer set well below the top of the cement surrounding the 5 ½-inch casing.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
