Newmont Oil Company hereby requests administrative approval to convert to water injection, the West Loco Hills Unit Tract 4 Well No. 2, Unit letter N, 990' FSL and 2310' FWL of Section 12, Township 18-S, Range 29-E, in the West Loco Hills Grayburg No. 4 Sand Unit, Eddy County, New Mexico.

This well is in Stage I of the Newmont Operated Project which was established by Order No. R-2166 and amended under Order No. R-2178-C (Case 2805) dated 6-11-63. The location of the well and other pertinent data are shown on the plat and diagrammatic sketches hereto attached in compliance with the requirements as set forth by the above reference orders.


