ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3346, Burscan Oil Company has made application to the Commission on March 26, 1968, for permission to expand its Burwinkle and Scanlon Chaco Wash Water Flood Project in the Chaco Wash-Mesaverde Oil Pool, McKinley County, New Mexico.

NOW, on this 10th day of April, 1968, the Secretary-Director finds:

1. That application has been filed in due form.

2. That satisfactory information has been provided that all offset operators have been duly notified of the application.

3. That no objection has been received within the waiting period as prescribed by Order No. R-3346.

4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-3346.

5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.

6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Burscan Oil Company, be and the same is hereby authorized to inject water into the Mesaverde formation through the following described well for purposes of secondary recovery, to wit:

Well No. 8 located 1980 feet from the West Line and 330 feet from the North Line of Section 28, Township 20 North, Range 9 West, NMPM,
