ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Sun Oil Company DX Division has made application to the Commission on February 20, 1969, for permission to expand its SDX Metex Water Flood Project in the Grayburg-Jackson Pool, Eddy County, New Mexico.

NOW, on this 7th day of March, 1969, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Sun Oil Company DX Division, be and the same is hereby authorized to inject water into the Grayburg formation through the following described wells for purposes of secondary recovery, to wit:

M. Dodd "A" Well No. 9 located in Unit G of Section 22,  
M. Dodd "A" Well No. 10X located in Unit A of Section 22,  
and M. Dodd "A" Well No. 11 located in Unit I of Section  
22, all in Township 17 South, Range 29 East, NMPM.
