ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3214, Skelly Oil Company has made application to the Commission on December 28, 1970, for permission to expand its Grayburg-Jackson Skelly Unit Water Flood Project in the Grayburg-Jackson Pool, Eddy County, New Mexico.

NOW, on this 12th day of January, 1971, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-3214.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-3214.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Skelly Oil Company, be and the same is hereby authorized to inject water into the Grayburg formation through the following-described wells for purposes of secondary recovery, to wit:

Unit Well No. 69 located in Unit L of Section 21,  
Unit Well No. 91 located in Unit D of Section 28, and  
Unit Well No. 100 located in Unit L of Section 28,  
all in Township 17 South, Range 31 East, NMPM.

PROVIDED HOWEVER, that the applicant shall inject water through tubing with packers set as close to the injection zone as is practical.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
