ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, Wood, McShane and Thams-Colorado has made application to the Commission on November 8, 1971, for permission to expand its State "M" Lease Water Flood Project in the Langlie-Mattix Pool, Lea County, New Mexico.

NOW, on this 23rd day of November, 1971, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced waterflood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:


That the applicant, Wood, McShane and Thams-Colorado, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

State "M" Well No. 34 located in Unit D of Section 29 and State "M" Well No. 47 located in Unit N of Section 20, both in Township 22 South, Range 37 East, NMPM.

PROVIDED HOWEVER, That the applicant shall inject water through tubing with packers set at approximately 3400 feet in the above described wells.
