Gentlemen:

Wood, McShane & Thams are operators of the New Mexico "M" State Waterflood Project, formerly operated by Humble Oil & Refining Company and approved by Commission Order No. R-2556 and extended by Order No. R-2891. Wood, McShane & Thams hereby requests administrative approval to expand waterflood development under the provisions of Oil Conservation Commission Rule 701-E-5.

Order No. R-3910 authorizes the drilling of and conversion of wells at unorthodox locations through administrative approval so that the project will essentially be altered to 40-acre flood patterns. The initial phase of this program will be the conversion of New Mexico "M" State Nos. 34 and 47, both of which are slim-hole completions. This will complete an approximate 40-acre flood pattern with "M" State No. 58 being a newly drilled and completed producer with 5½" oil string.

Plans are to inject into "M" State Nos. 34 and 47 at approximately three hundred barrels per day rate using recycled produced water as well as San Andres water from a water supply well located approximately four hundred feet west of "M" State No. 34.

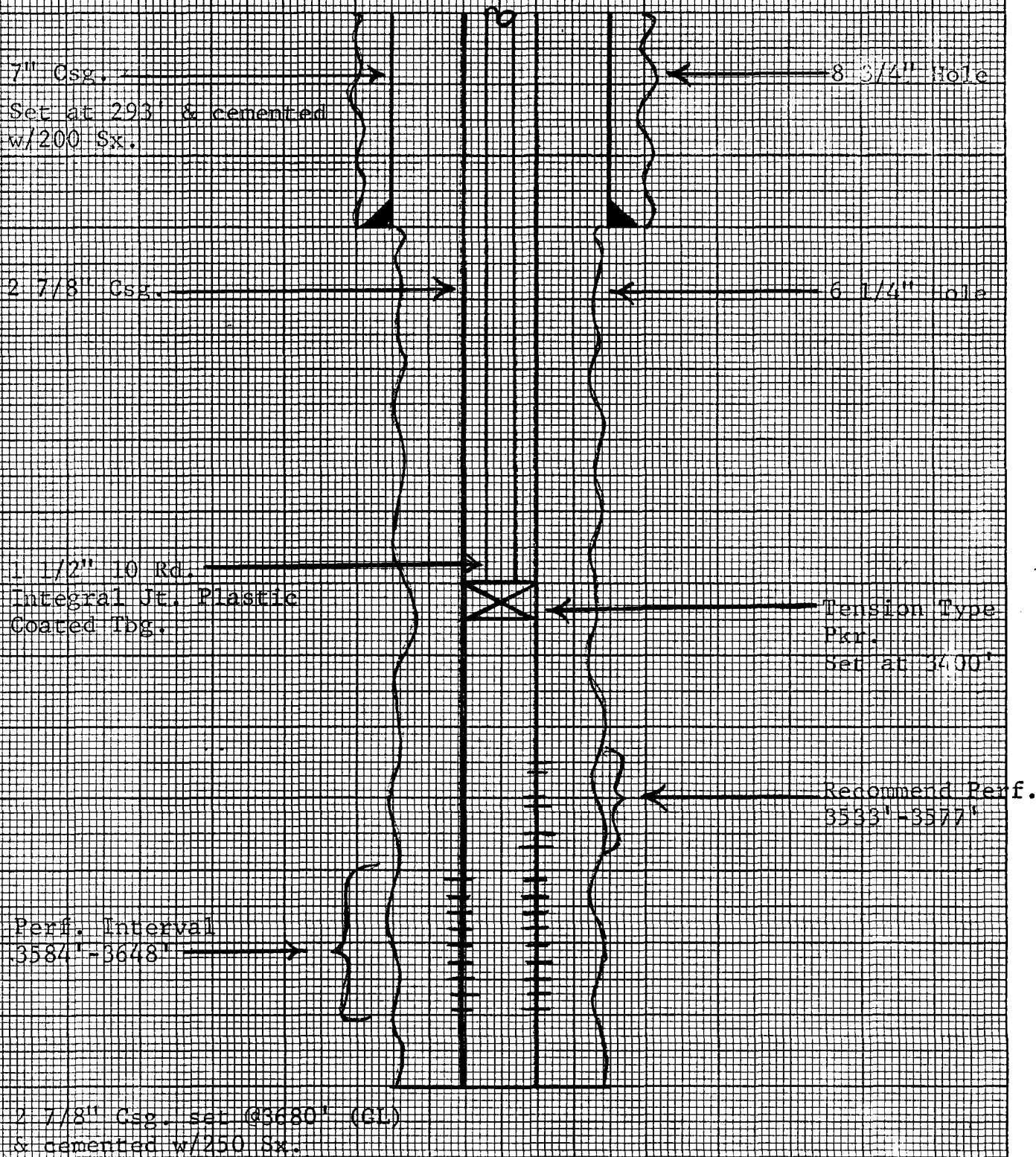

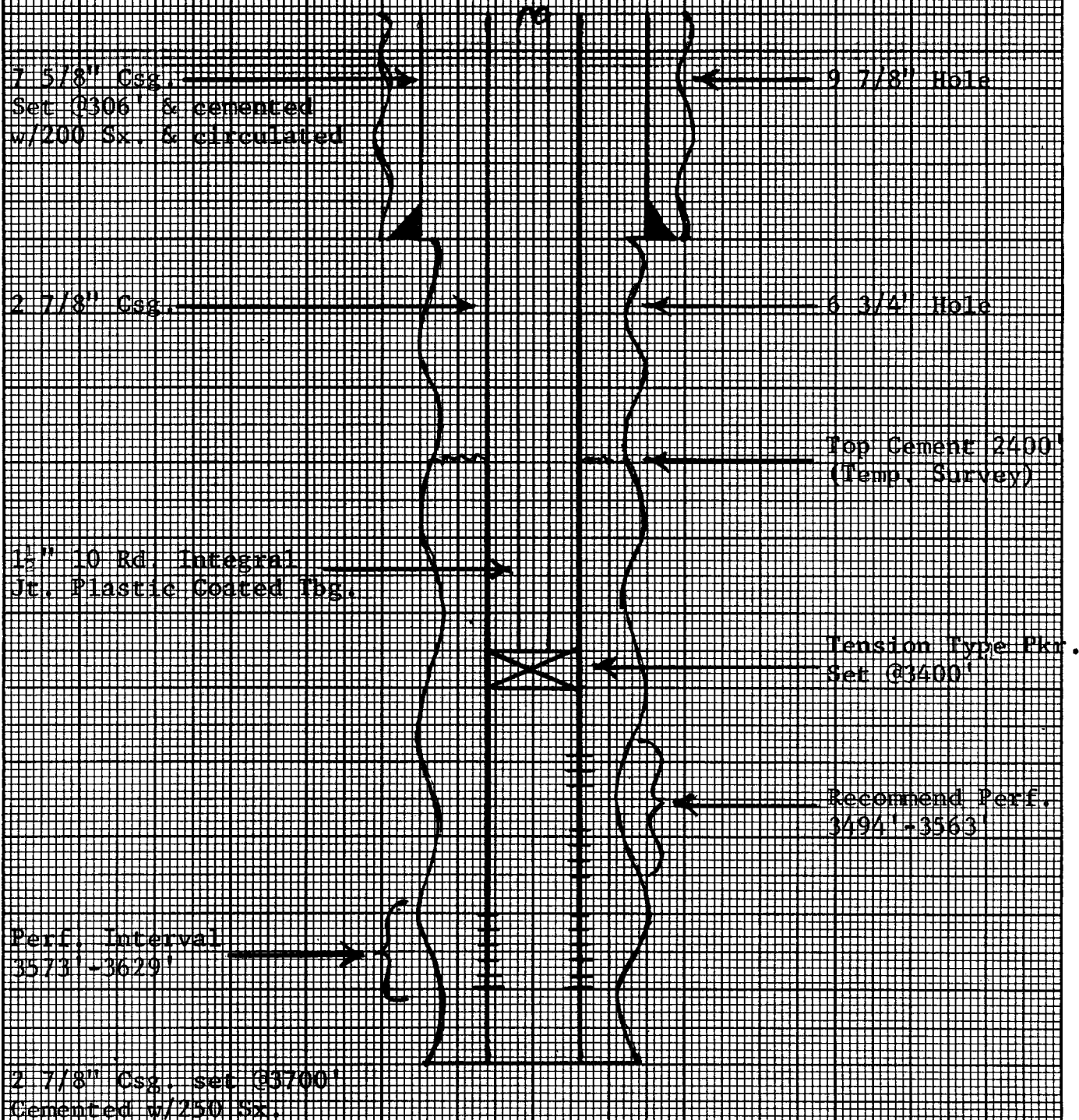

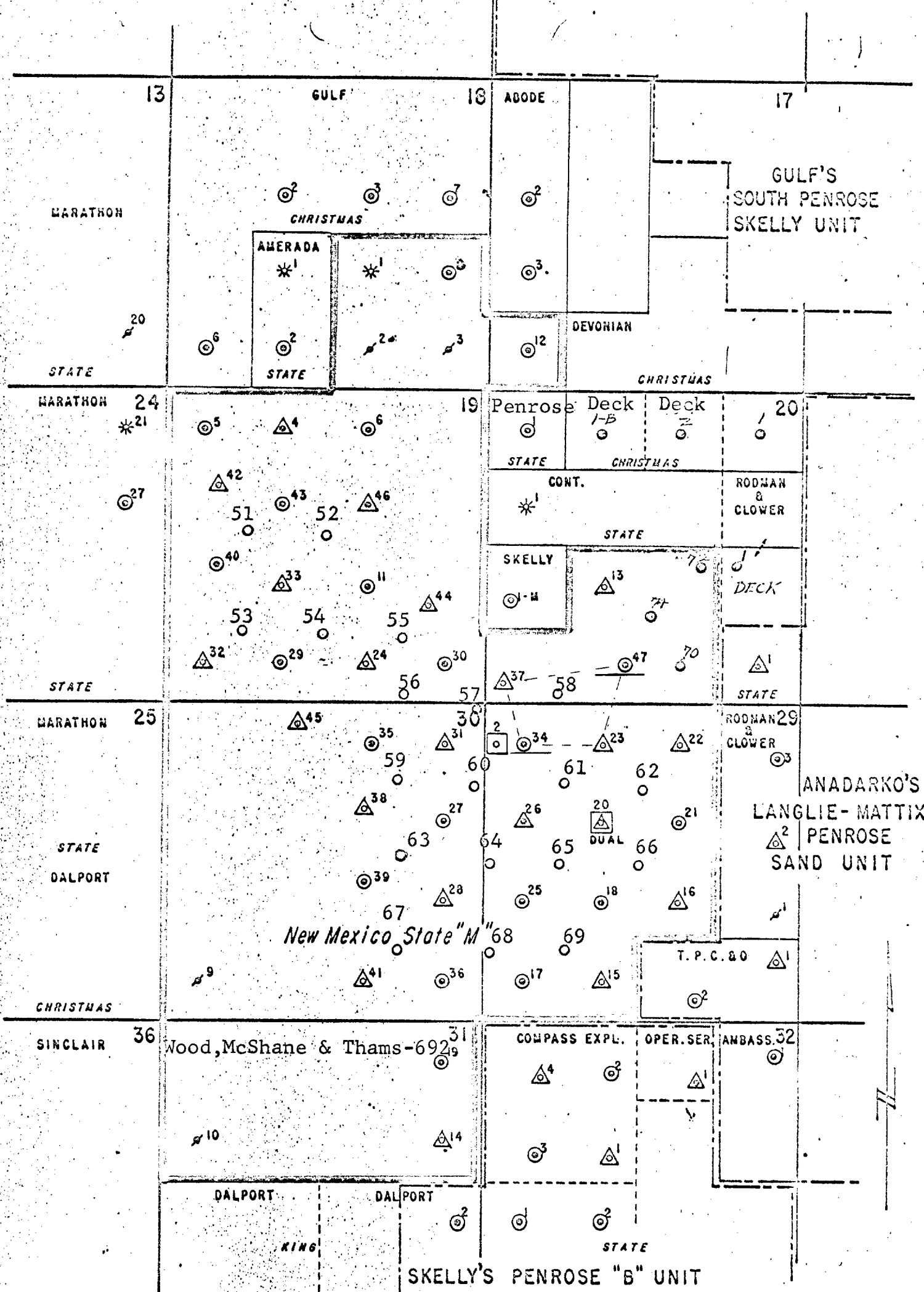
