ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 701, General American Oil Company of Texas has made application to the Commission on December 16, 1971, for permission to expand its Grayburg-Jackson Premier Sand Water Flood Project in the Grayburg-Jackson Pool, Eddy County, New Mexico.

NOW, on this 31st day of December, 1971, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Rule 701.
4. That the proposed injection wells are eligible for conversion to water injection under the terms of Rule 701.
5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.


IT IS THEREFORE ORDERED:

That the applicant, General American Oil Company of Texas, be and the same is hereby authorized to inject water into the Premier Sand formation through the following described wells for purposes of secondary recovery, to wit:

Maddren B Well No. 3 located in Unit N of Section 27,
and Beeson A Well No. 3 located in Unit O of Section
28, both in Township 17 South, Range 30 East, NMPM.

PROVIDED HOWEVER, That the applicant shall inject water through tubing with packers set at approximately 3100 feet in said wells.
