## ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-3593, Skelly Oil Company has made application to the Commission on January 7, 1974, for permission to expand its Skelly Langlie Mattix Steeler Water Flood Project in the Langlie-Mattix Pool in Lea County, New Mexico.

NOW, on this 22nd day of January, 1974, the Secretary-Director finds:

1. That application has been filed in due form.

2. That satisfactory information has been provided that all offset operators have been duly notified of the application.

3. That no objection has been received within the waiting period as prescribed by Order No. R-3593.

4. That the proposed injection wells are eligible for conversion to water injection under the terms of Order No. R-3593.

5. That the proposed expansion of the above-referenced water flood project will not cause waste nor impair correlative rights.

6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Skelly Oil Company, be and the same is hereby authorized to inject water into the Queen formation through the following described wells for purposes of secondary recovery, to wit:

> E. L. Steeler Well No. 1, Unit B, E. L. Steeler Well No. 3, Unit H, E. L. Steeler Well No. 7, Unit L,

all located in Section 17, Township 23 South, Range 37 East, NMPM.

That injection into each of said wells shall be through tubing which is internally coated or lined with plastic or cement and set in a packer which is located above and as near as practicable to the uppermost perforation and that the casing-tubing annulus of each injection well shall be loaded with an inert fluid and equipped with an approved pressure gauge or attention-attracting leak detection device.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
