ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4049, Anadarko Production Company has made application to the Commission on August 23, 1974, for permission to expand its Federal "R" Lease Water Flood Project in the Square Lake Pool, Eddy County, New Mexico.

NOW, on this 9th day of September, 1974, the Secretary-Director finds:

1. That application has been filed in due form.

2. That satisfactory information has been provided that all offset operators have been duly notified of the application.

3, That no objection has been received within the waiting period as prescribed by Order No. R-4049.

4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-4049.
