Dear Mr. Sirgo:


Reference is made to your request dated April 23, 1990, to increase the surface injection pressure on fourteen wells within the West Dollarhide Queen Sand Unit Waterflood Project. This request is based on step rate tests conducted on these wells during April, 1990. The results of the tests have been reviewed by my staff and we feel an increase in injection pressure on the majority of these wells is justified at this time.

You are therefore authorized to increase the surface injection pressure on the wells shown on Exhibit "A" attached hereto.

Based on a recommendation from the supervisor of the Division's Hobbs district office, we are requiring that the step rate tests conducted on Well Nos. 136, 142 and 143 be reconducted and resubmitted prior to the approval of any increase in injection pressure.

The Division Director may rescind this injection pressure increase if it becomes apparent that the injected water is not being confined to the injection zone or is endangering any fresh water aquifers.
