Dear Ms. de Aragao:

Reference is made to your request dated September 30, 1994 to increase the surface injection pressure on 12 wells. This request is based on step rate tests conducted on these wells between August 11 and September 1, 1994. The results of the tests have been reviewed by my staff and we feel an increase in injection pressure on these wells, with the exception of WDDU No.21, is justified at this time.

You are therefore authorized to increase the surface injection pressure on the following wells:
