
Gentlemen:

Please accept this letter as our official "Notice of Objection" to the complete referenced program. Our objection at this time is only because of a lack of proper notification. The only notice we have received is the attached certified letter. This notice does not provide us with the individual well data for the wells in the three sections that they plan to convert to water injection wells. Since notice is required for a well that is within 1/2 mile it would be necessary to have the individual well data to either object or not object to their well conversion. We do not believe this required proper and complete notice has been sent to the offset operators at this time.
