ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4263, Tenneco Oil Company has made application to the Commission on March 15, 1972, for permission to expand its Lone Pine Dakota "D" Pressure Maintenance Project in the Lone Pine-Dakota "D" Oil Pool, McKinley County, New Mexico.

NOW, on this 4th day of April, 1972, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-4263.
4. That the proposed injection well is eligible for conversion to water injection under the terms of Order No. R-4263.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:


That the applicant, Tenneco Oil Company, be and the same is hereby authorized to inject water into the Dakota "D" formation through the following described well for purposes of pressure maintenance, to wit:

Connelly-Federal Well No. 1 located in Unit L of Section 17, Township 17 North, Range 8 West, NMPM.

PROVIDED HOWEVER, that applicant shall inject water through tubing with a packer set at approximately 2685 feet in said well.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
