ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4430, Mobil Oil Corporation has made application to the Commission on August 31, 1973, for permission to expand its North Vacuum Abo Unit Pressure Maintenance Project in the North Vacuum-Abo Pool, Lea County, New Mexico.

NOW, on this 20th day of September, 1973, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-4430.
4. That the proposed injection wells are eligible for conversion to gas and water injection under the terms of Order No. R-4430.
5. That the proposed expansion of the above-referenced pressure maintenance project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:


That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject gas and water into the Abo formation through the following described wells for purposes of pressure maintenance to wit:

Unit Well No. 216 located in Unit H and Unit Well No.  
217 located in Unit F, both in Section 11, Township  
17 South, Range 34 East, NMPM.

PROVIDED HOWEVER, That the applicant shall inject fluids through tubing with packers set approximately 50 feet above the top perforation.
