ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4263, Tenneco Oil Company has made application to the Commission on December 13, 1973, for permission to expand its Lone Pine Dakota "D" Pressure Maintenance Project in the Lone Pine Dakota "D" Oil Pool in McKinley County, New Mexico.

- 1. That application has been filed in due form.
- 2. That there are no offset operators and the waiting period as prescribed by Order No. R-5263 may be waived.
