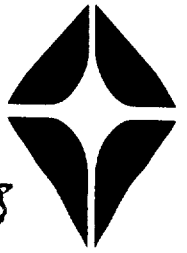

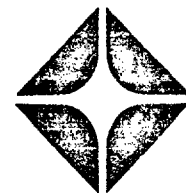

Atlantic Richfield Company, as operator of the Empire Abo Unit Pressure Maintenance Project, acting on behalf of itself and the other participating working interest owners, requests administrative approval under the provisions of Order No. R-4549-B, Rule 14, under "Special Rules and Regulations for the Empire Abo Pressure Maintenance Project," for the designation of Unit Wells C-39, D-35, G-24, H-21, and I-18 to gas injection wells.

The redesignation of Unit Wells C-39, D-35, G-24, H-21, and I-18 to gas injection wells, meets all requirements of Order R-4549-B Rule 14, said wells being located "no closer than 660 feet to the outer boundary of said unit, nor closer than 10 feet to any quarter-quarter section or subdivision inner boundary and provided that no well will be approved for gas or water injection when such well is located closer than 1650 feet to a tract which is not committed to the Unit and on which is located a well producing from the same common source of supply."

The redesignation of Empire Abo Unit Wells C-39, D-35, G-24, H-21, and I-18 is necessary to complete a more efficient injection pattern, promote the greatest ultimate recovery of reserves, prevent waste, and protect correlative rights.

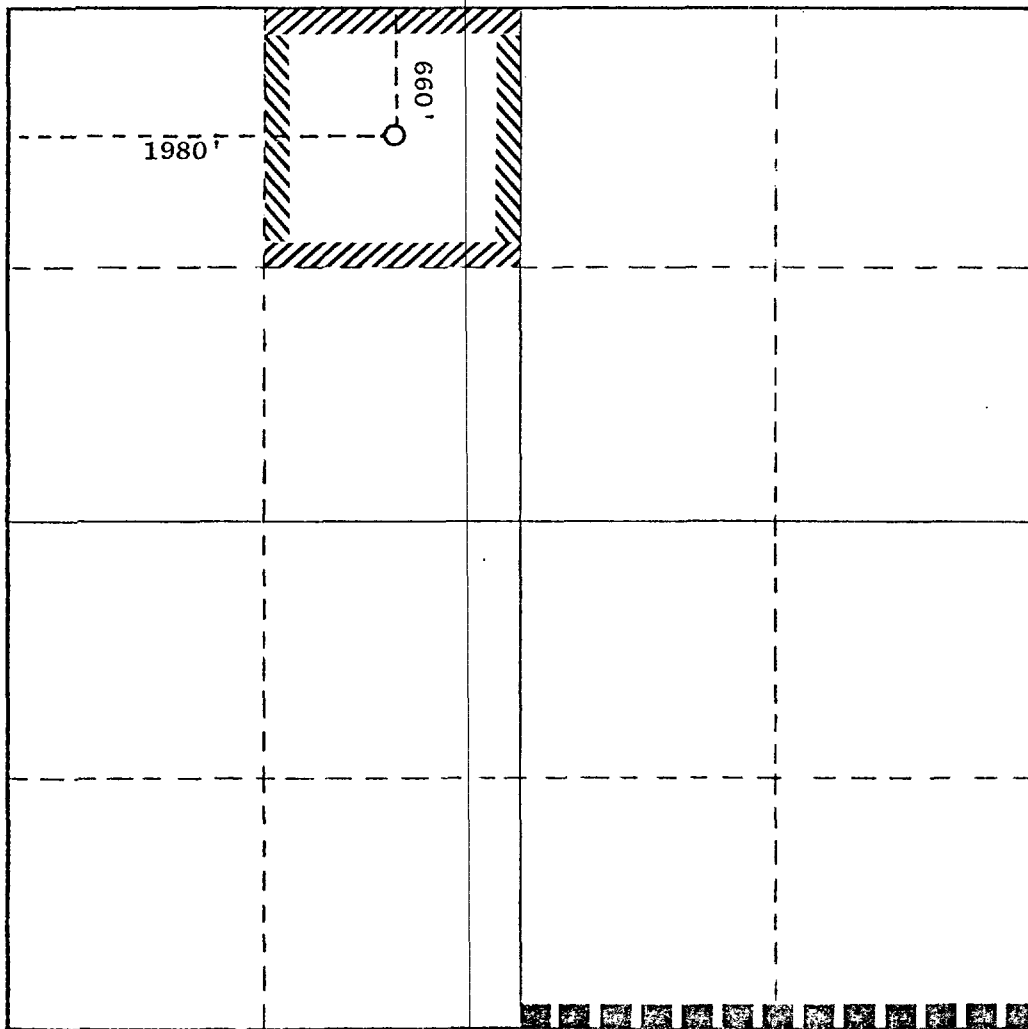

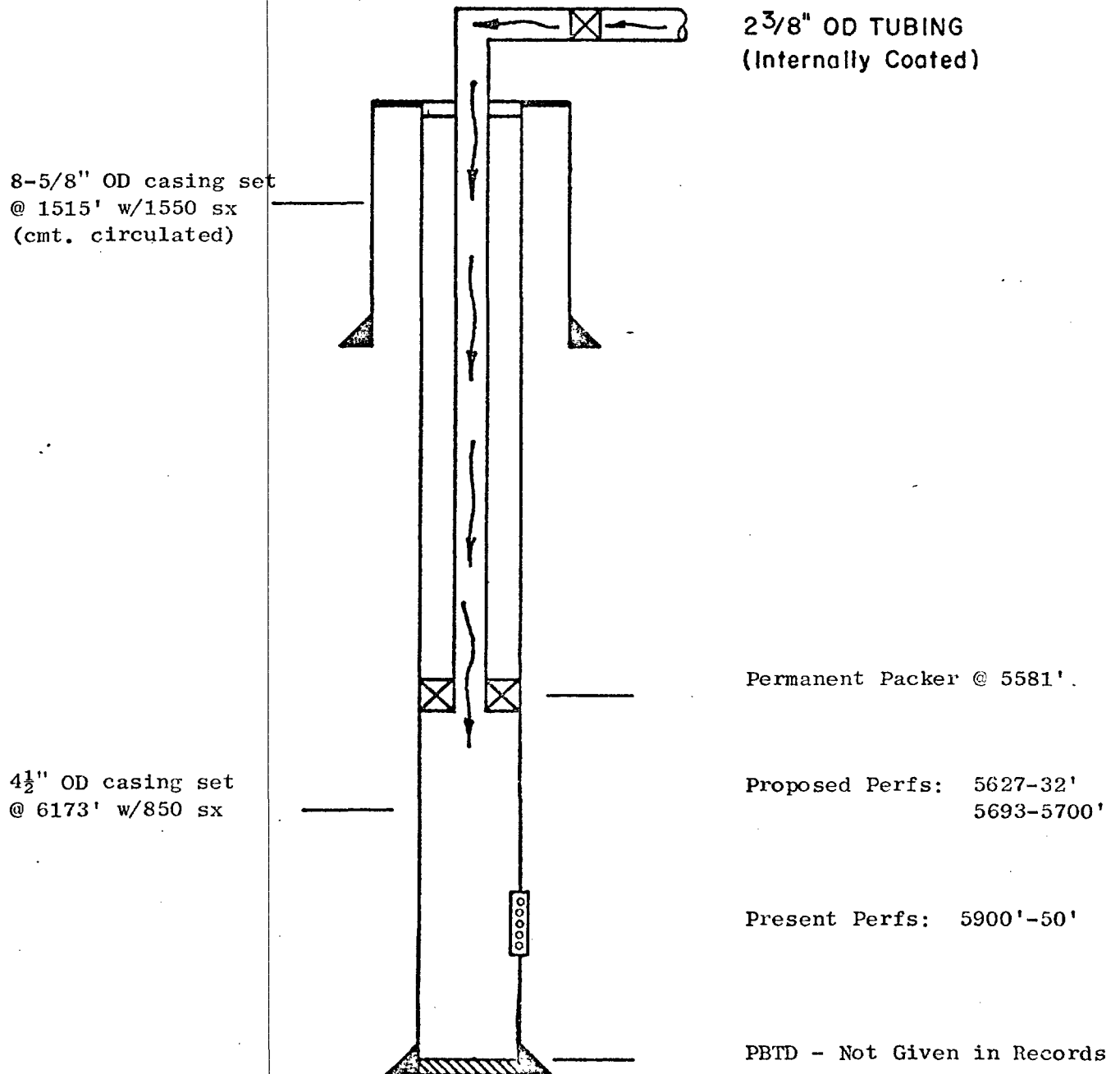

INJECTION WELL DIAGRAM



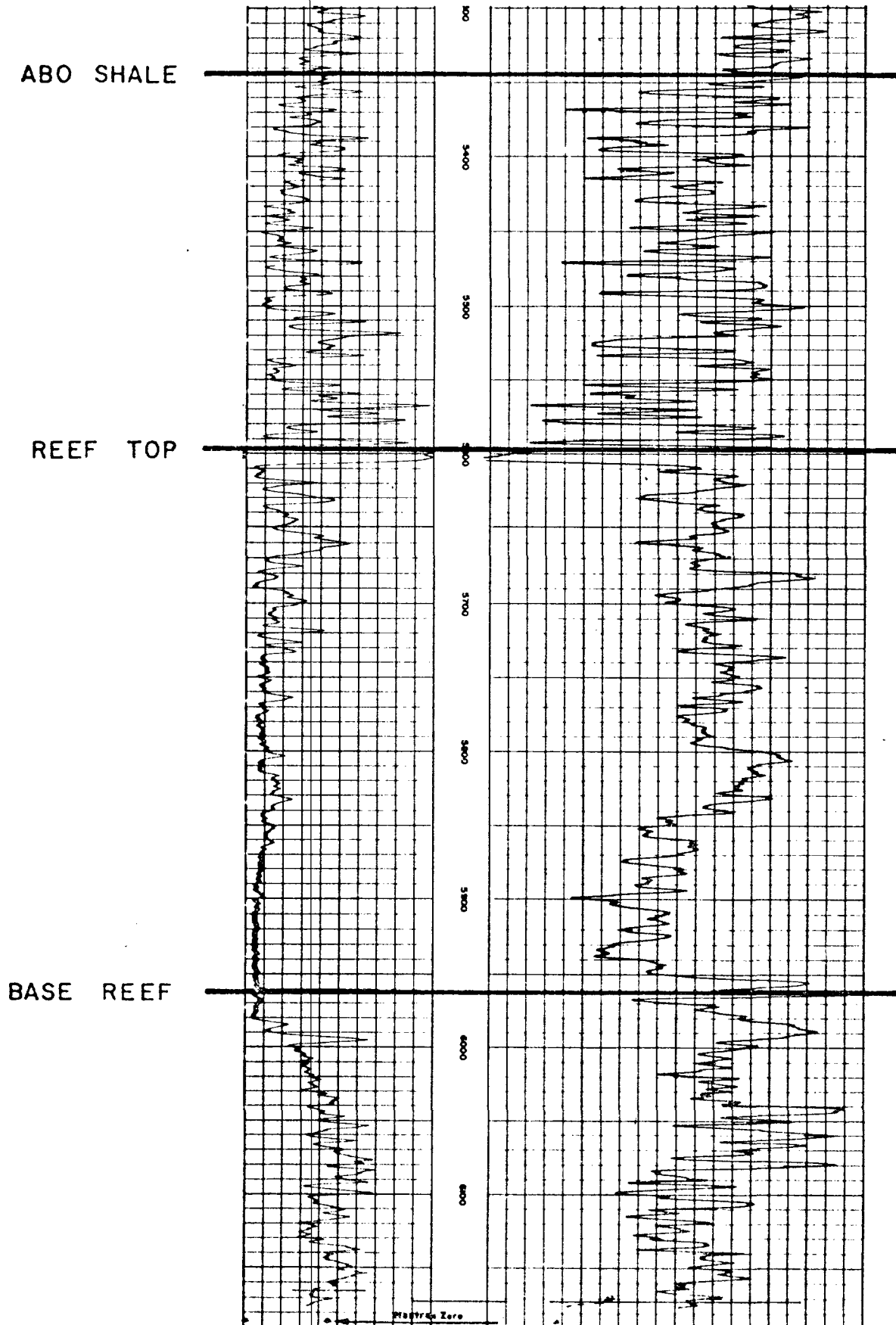

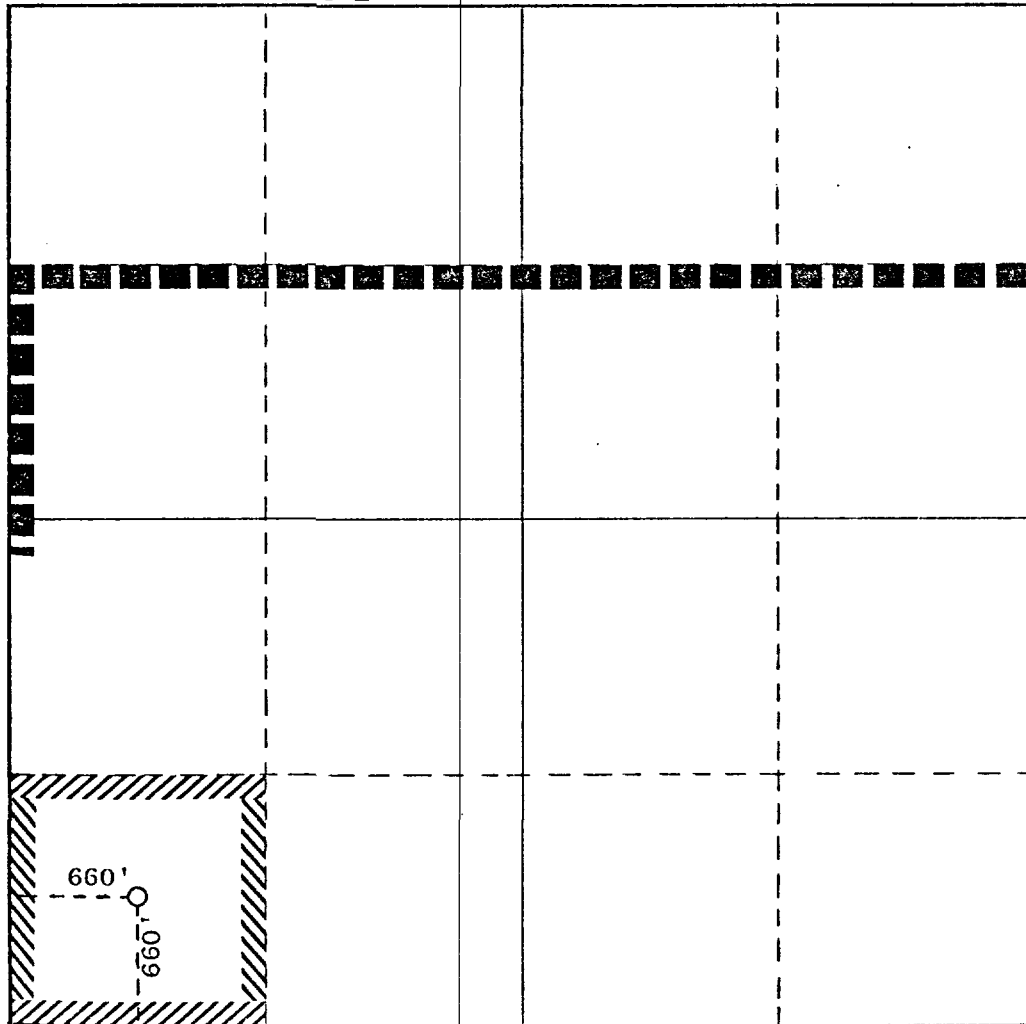

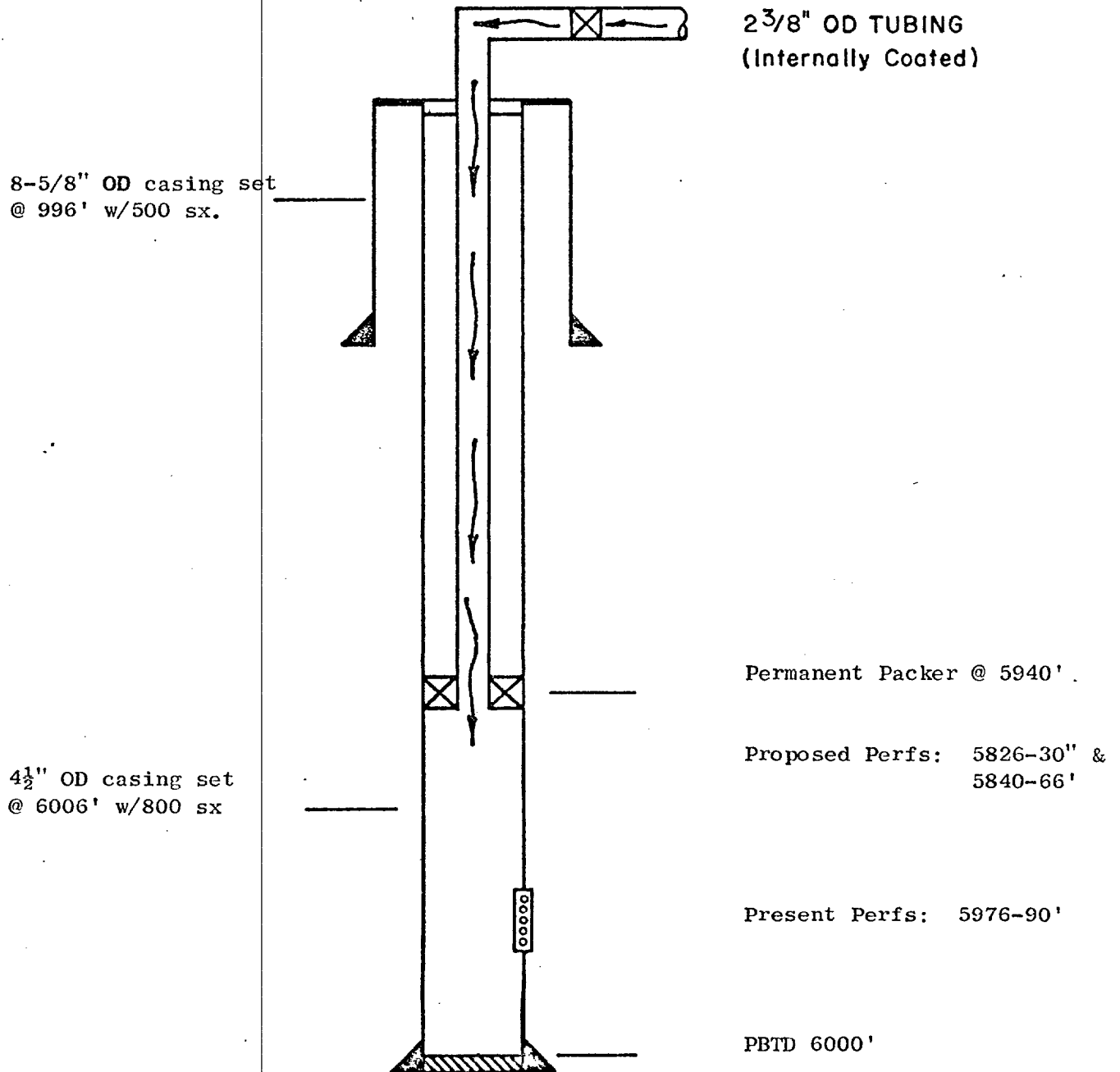

INJECTION WELL DIAGRAM



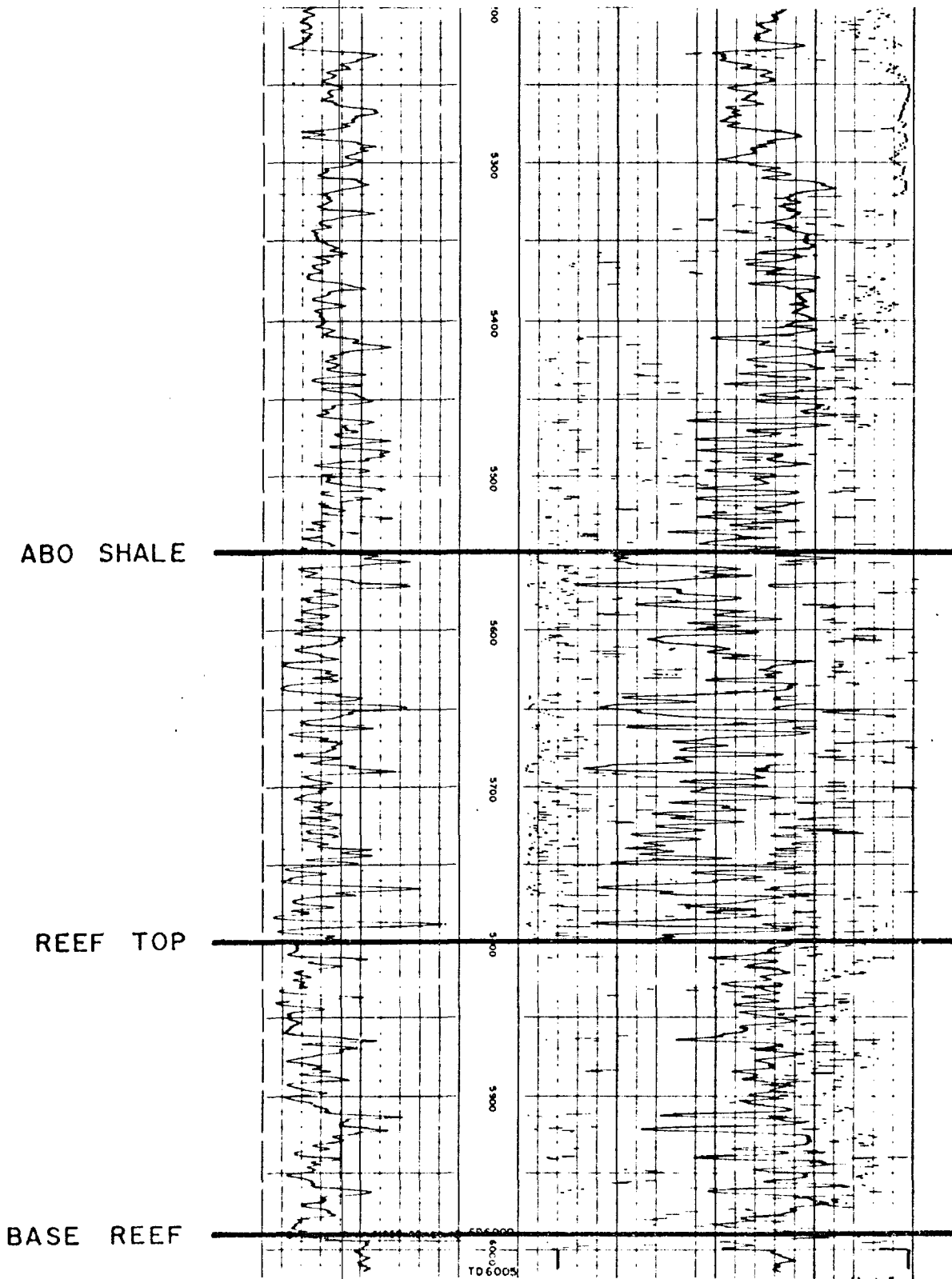

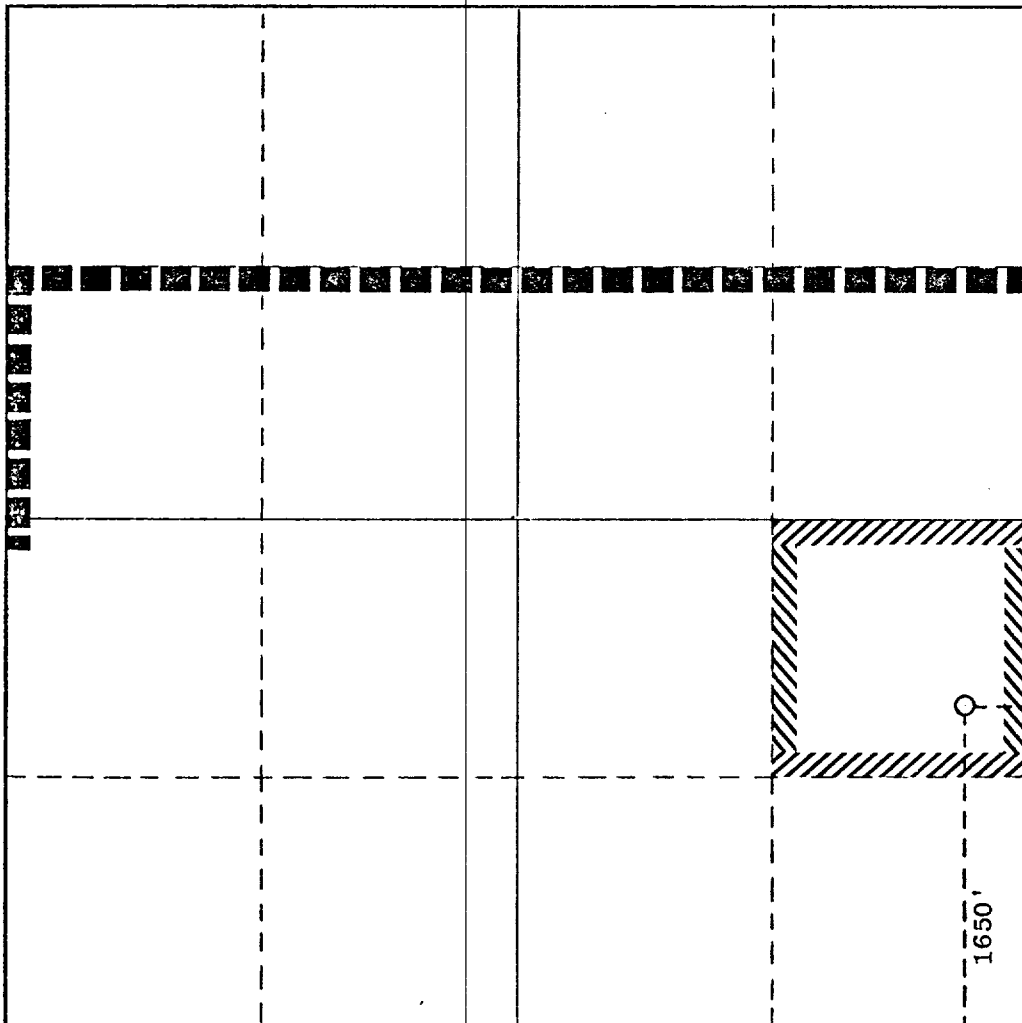

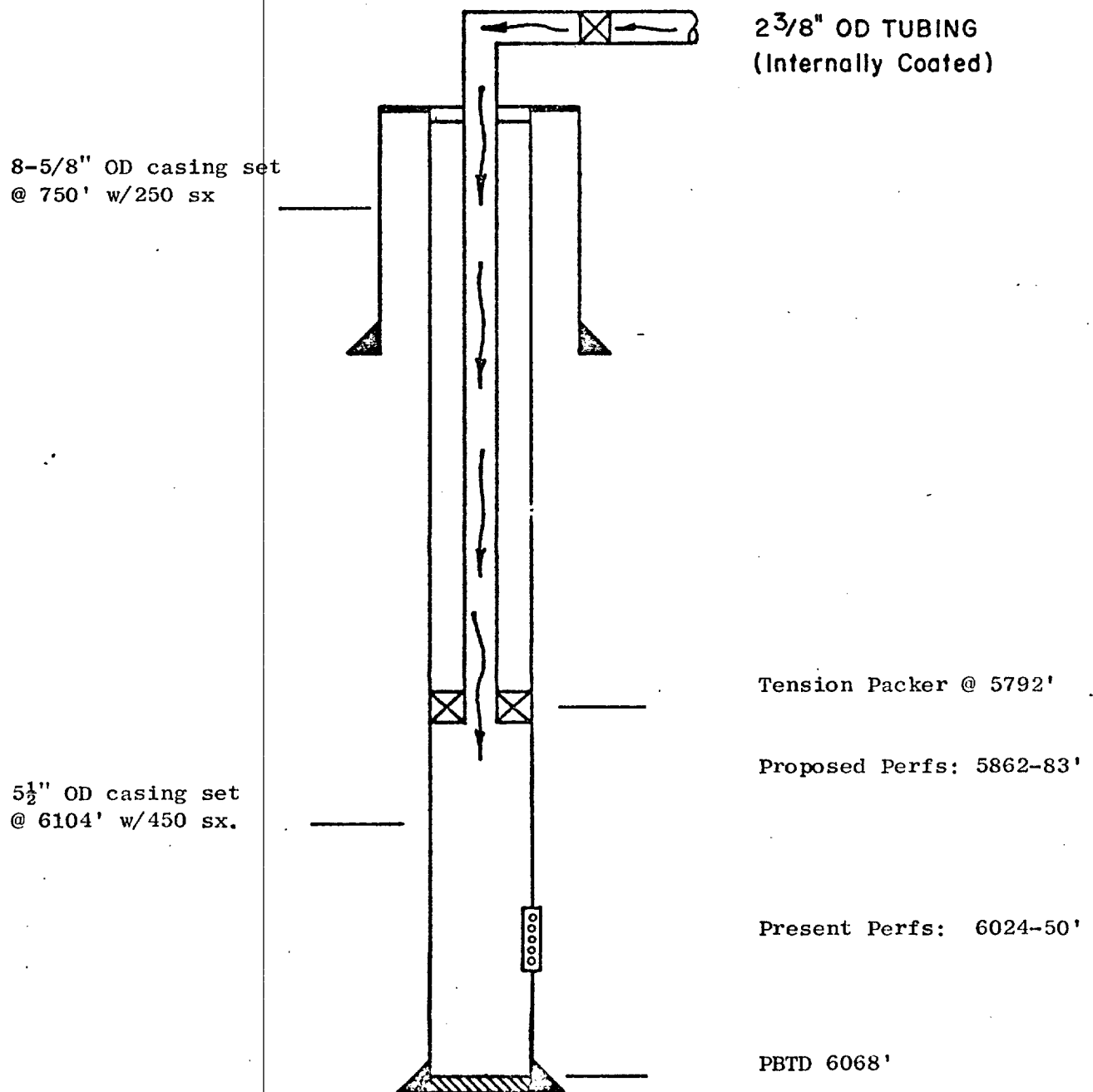

INJECTION WELL DIAGRAM

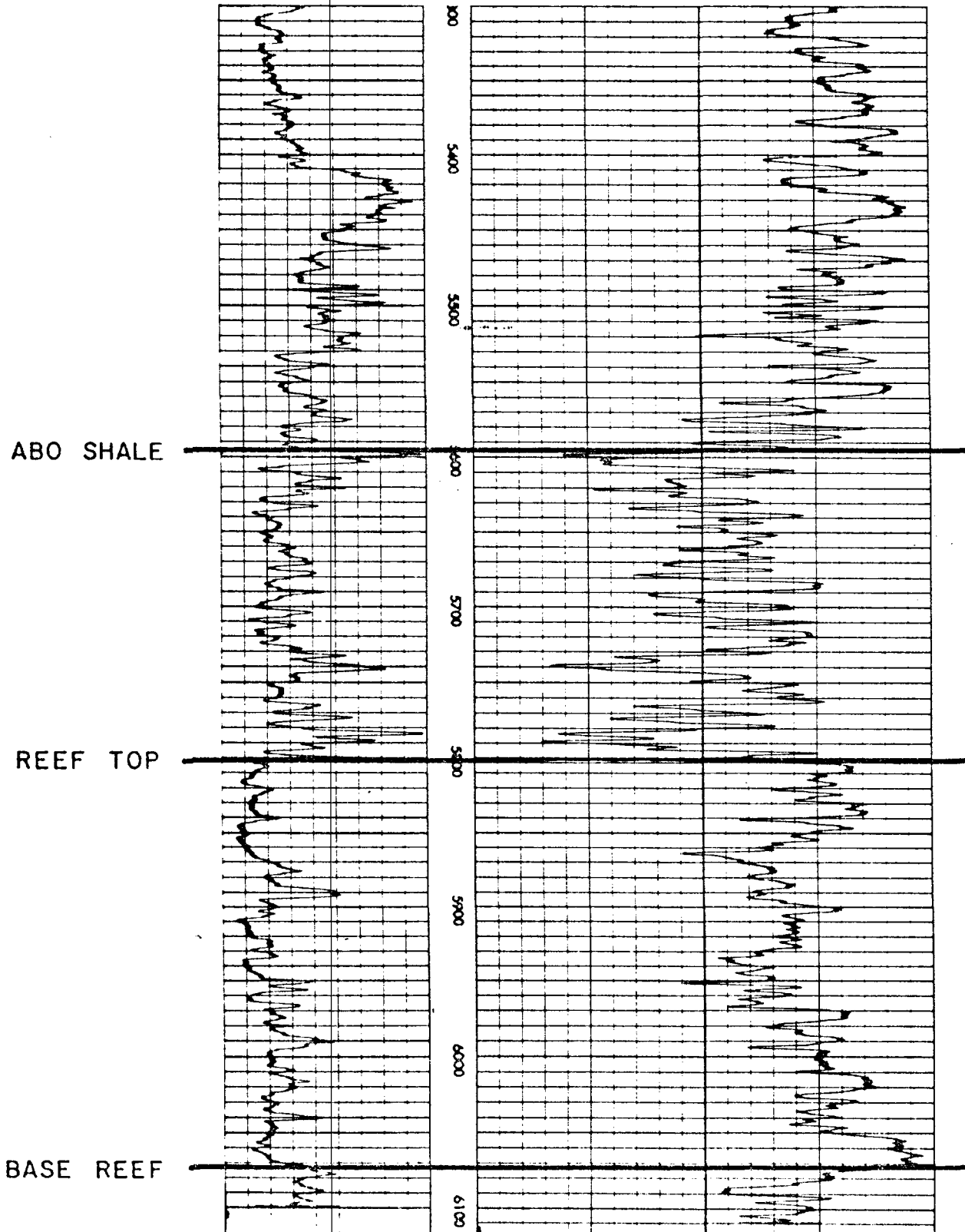

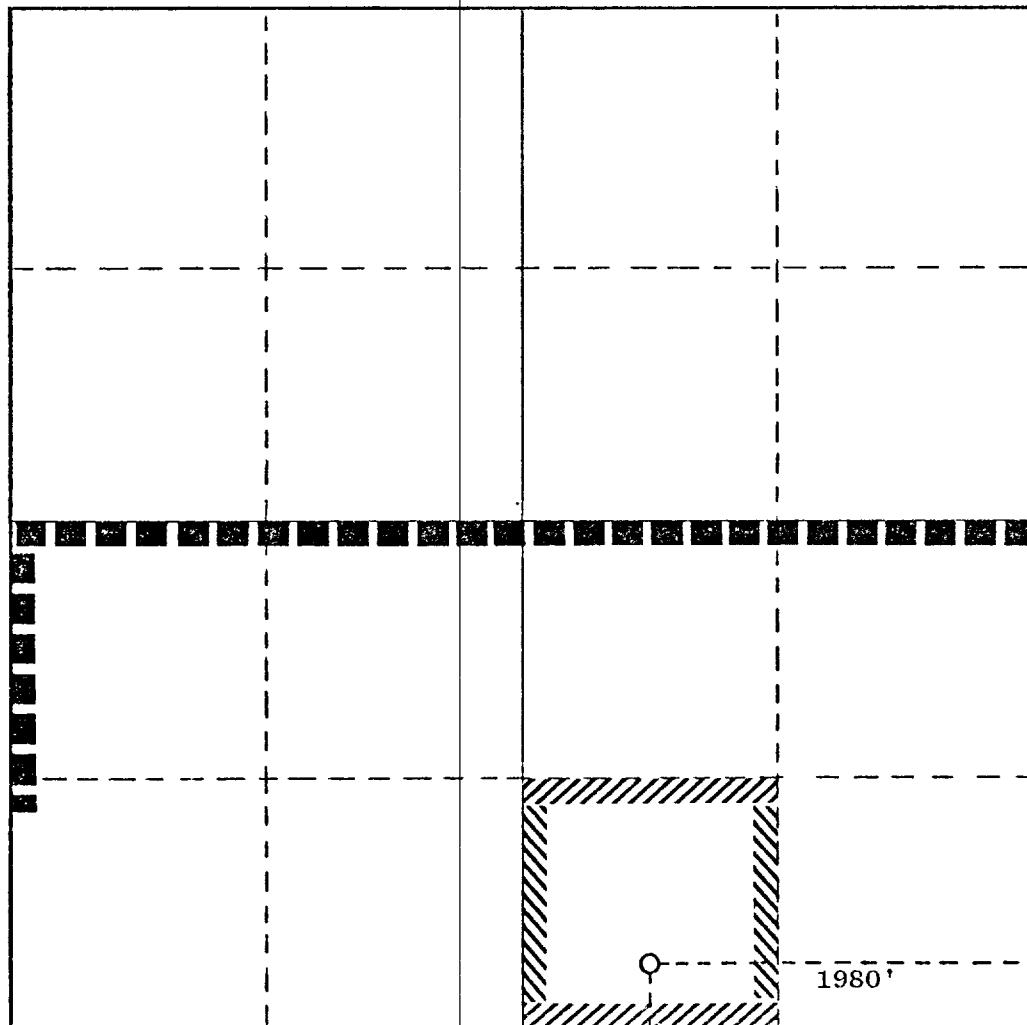

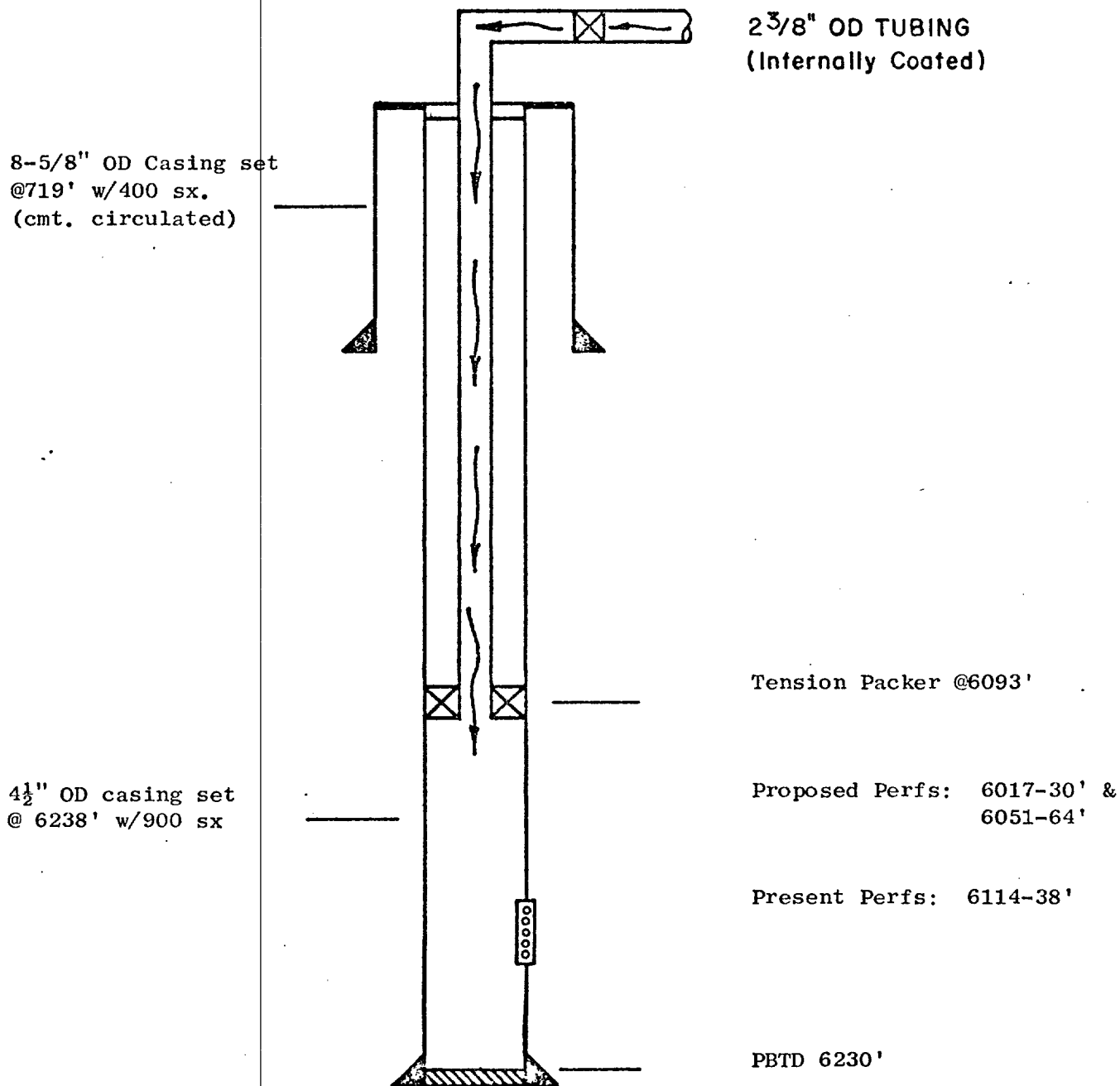

 INJECTION WELL DIAGRAM



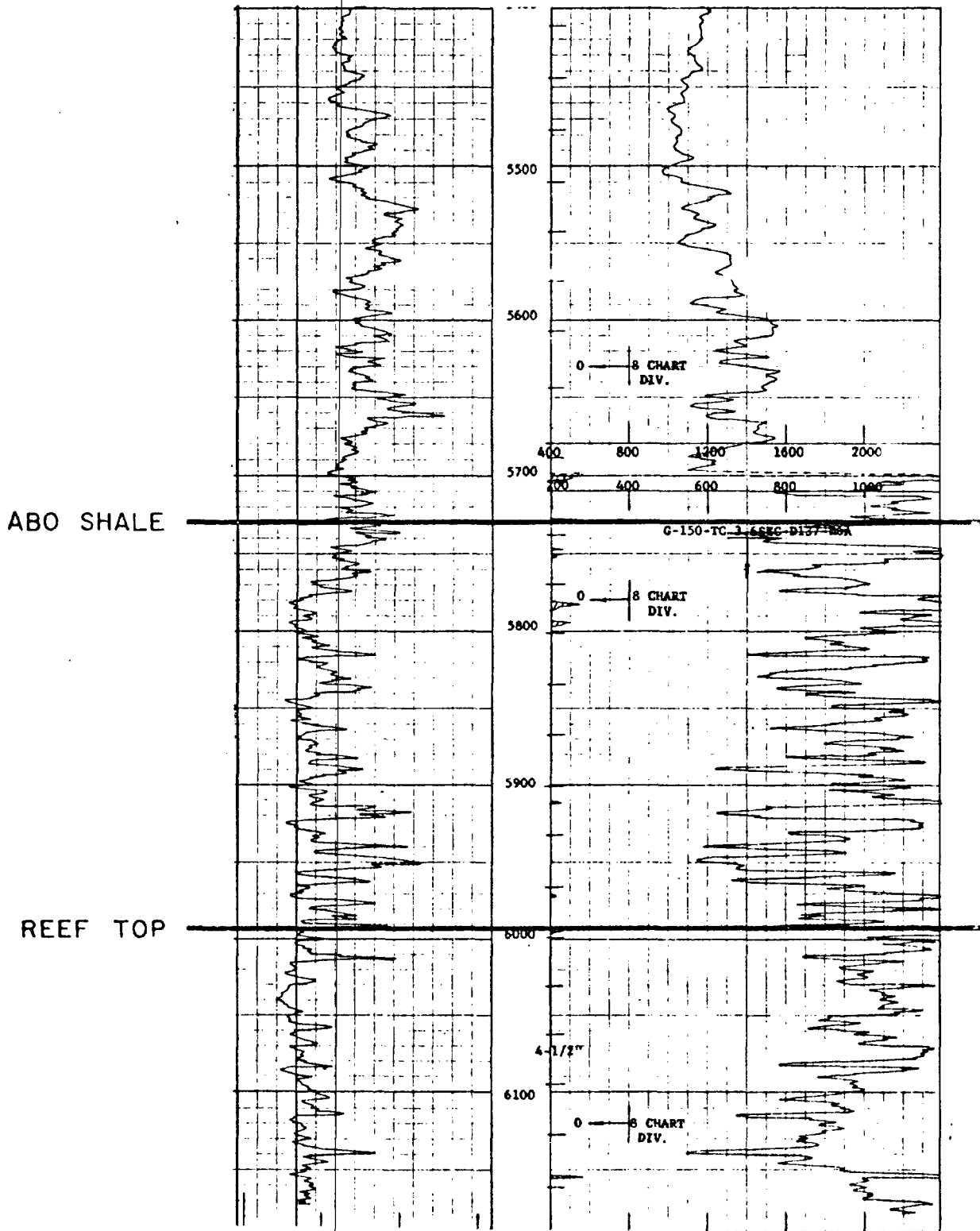

 INJECTION WELL DIAGRAM



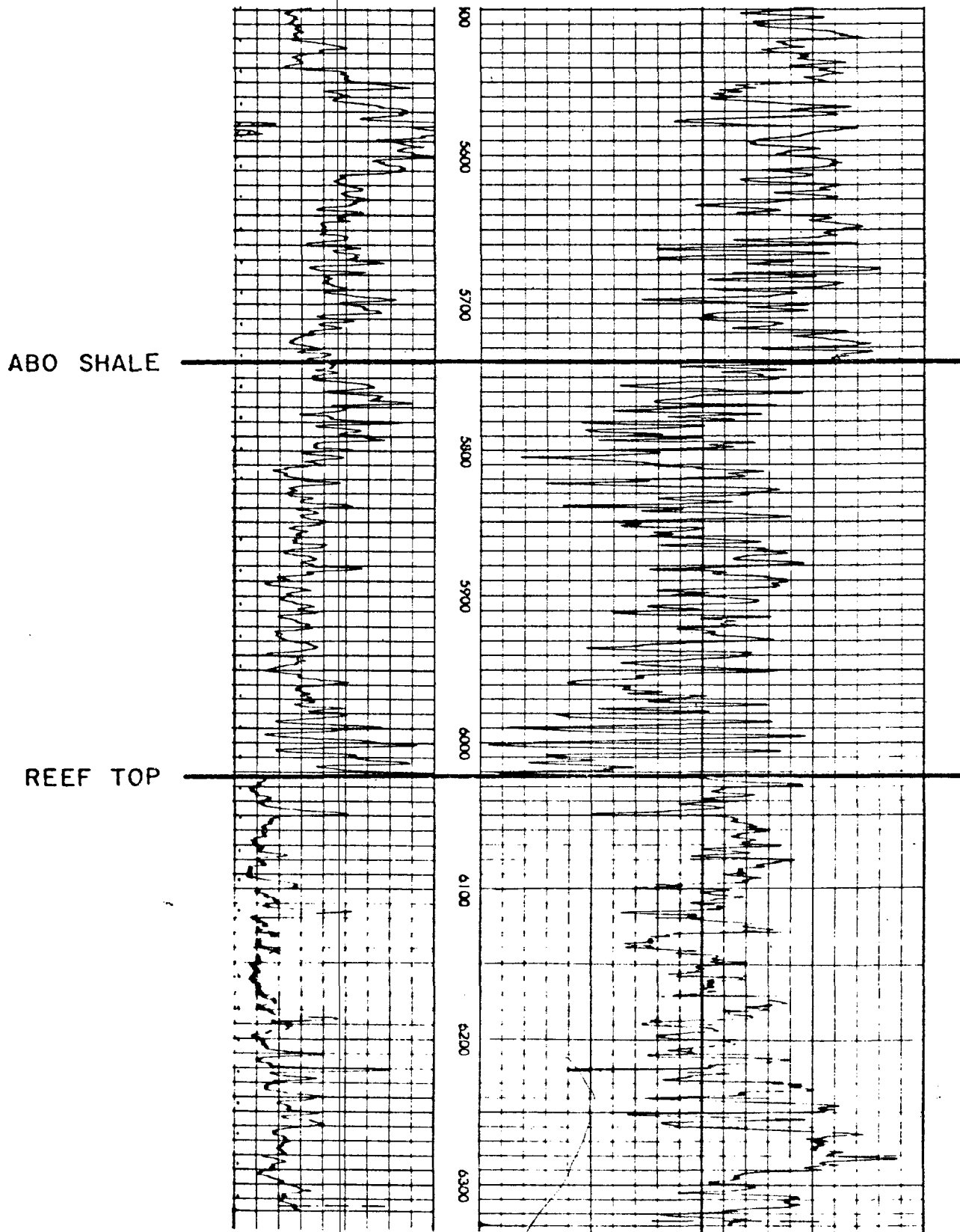

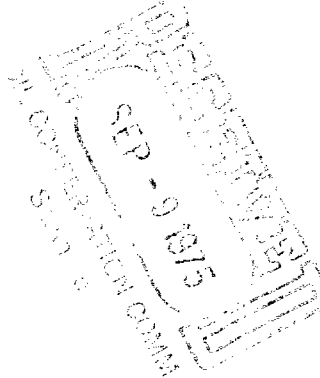
