ADMINISTRATIVE ORDER
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Order No. R-4430, Mobil Oil Corporation has made application to the Commission on March 24, 1977, for permission to expand its North Vacuum-Abo Pressure Maintenance Project in the North Vacuum-Abo Pool in Lea County, New Mexico.

NOW, on this 13th day of April, 1977, the Secretary-Director finds:

1. That application has been filed in due form.
2. That satisfactory information has been provided that all offset operators have been duly notified of the application.
3. That no objection has been received within the waiting period as prescribed by Order No. R-4430.
4. That the proposed injection wells are eligible for conversion to gas and water injection under the terms of Order No. R-4430.
5. That the proposed expansion of the above referenced water flood project will not cause waste nor impair correlative rights.
6. That the application should be approved.

IT IS THEREFORE ORDERED:

That the applicant, Mobil Oil Corporation, be and the same is hereby authorized to inject water into the Abo formation through plastic-lined tubing set in packers at approximately 8670 feet and 8500 feet, respectively, in the following described wells for purposes of secondary recovery, to wit:

North Vacuum-Abo Unit Well No. 228 located in Unit N of Section 10, and North Vacuum-Abo Unit Well No. 231 located in Unit P of Section 13, both in Township 17 South, Range 34 East, NMPM, Lea County, New Mexico.

IT IS FURTHER ORDERED:

That the operator shall take all steps necessary to ensure that the injected water enters only the proposed injection interval and is not permitted to escape to other formations or onto the surface.


That the casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of leakage in the casing, tubing, or packer.

That the operator shall notify the supervisor of the Commission's Hobbs District Office before injection is commenced through said well.

That the operator shall immediately notify the supervisor of the Commission's Hobbs office of the failure of the tubing, casing, or packer in said well or the leakage of water from or around said well and shall take such steps as may be timely or necessary to correct such failure or leakage

✓ Order No. R-4430, dated September 27, 1972, authorized Mobil Oil Corporation to institute pressure maintenance operations in the North Vacuum Abo Unit by the injection of gas and water into the Abo formations through certain wells. This order also gave the Secretary-Director the authority to approve the conversion of additional wells to injection service. The subject wells were not approved as injection wells by Order R-4430, since they were brought into the unit by an expansion which became effective November 1, 1976. The Commission approved this unit expansion by letter dated October 31, 1976.

In support of this application the following items are submitted:

1. Plat showing the proposed injection wells;
2. Diagrammatic wellbore sketch of each well; and
3. Log of each well with the injection interval indicated.

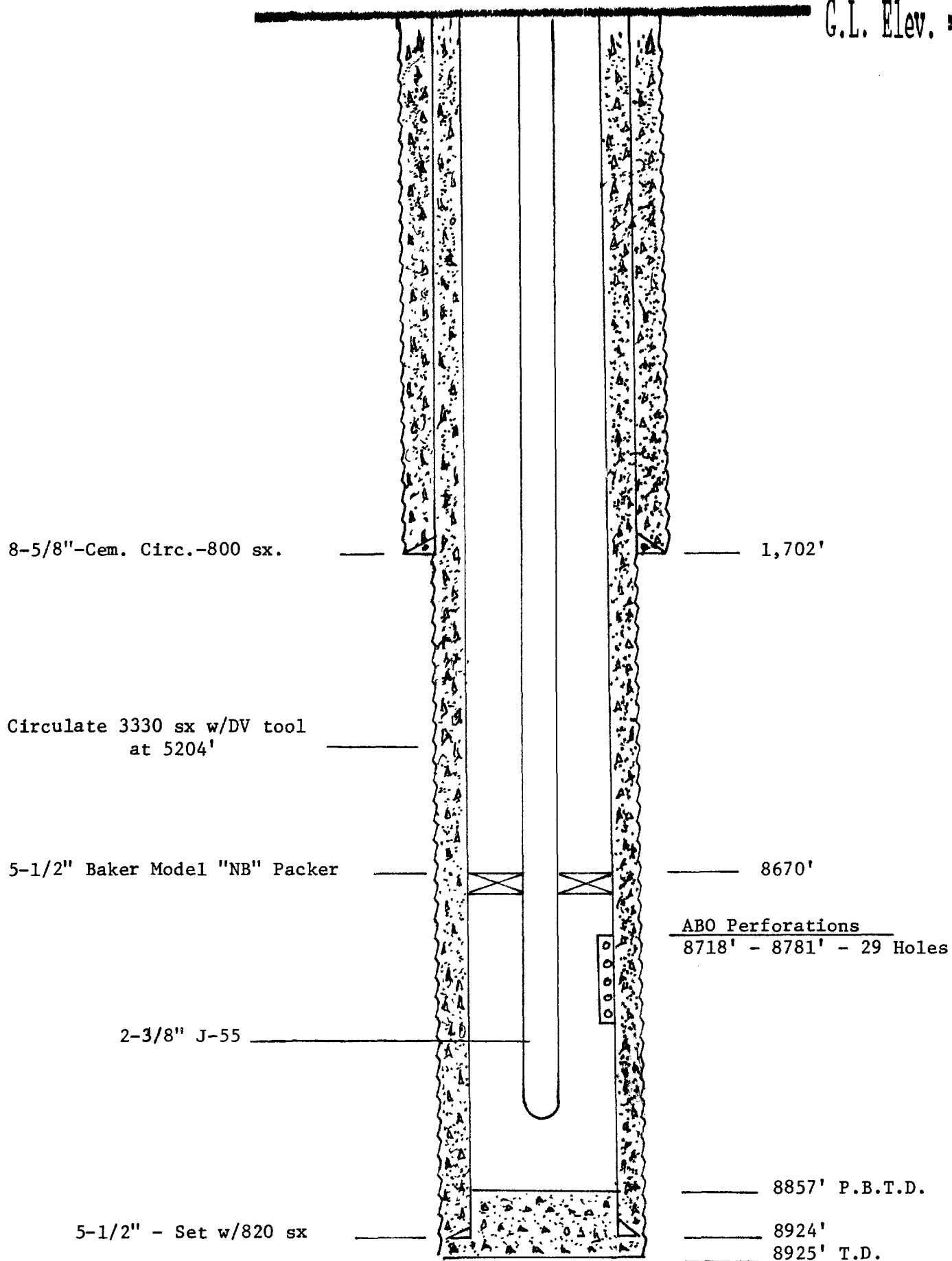
Plat N. Vacuum ABO Unit (Scale) Too large.

 LEA COUNTY, NEW MEXICO

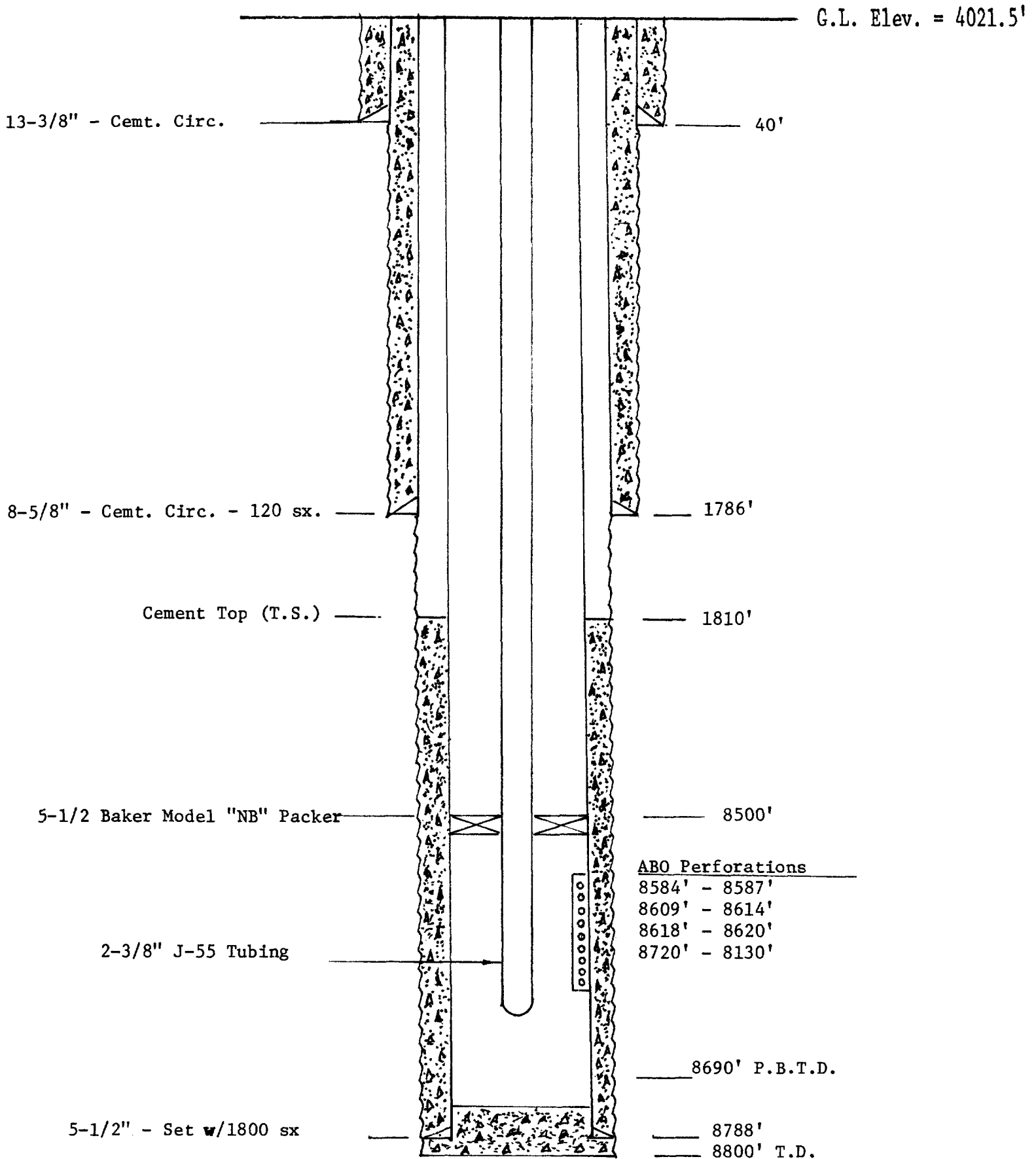


