Occidental Permian Limited Partnership respectfully requests administrative approval for expansion of the subject pressure maintenance project by amending the injection rate and injection pressure of produced water, and by adding CO₂ as an injectant for North Hobbs G/SA Unit No. 322 (see Exhibit I). 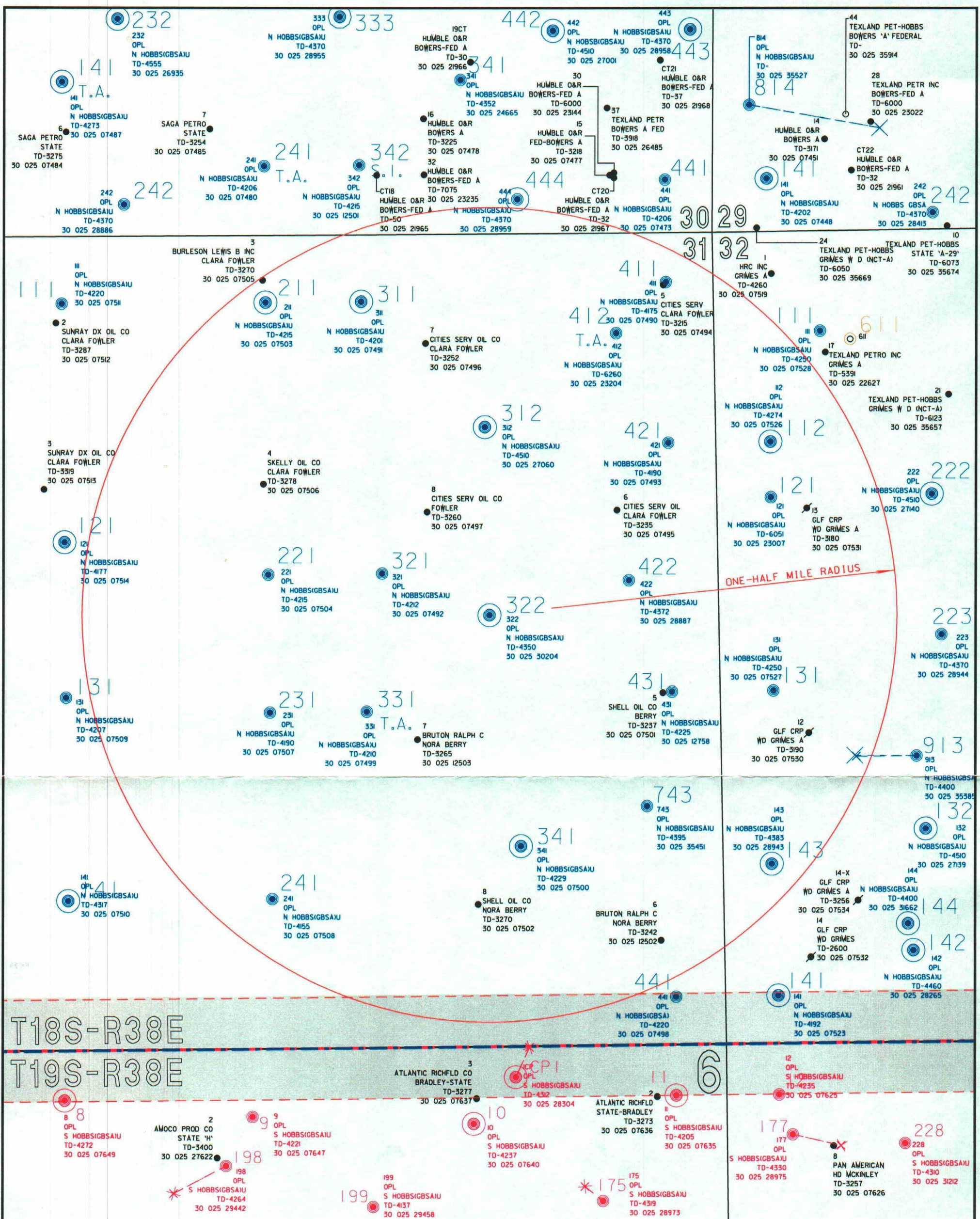
