## DESIGNATION OF AGENT

### Canyon Largo Unit Disposal Well #1

This indenture dated as of the 5th of September 1985, by and between EL PASO NATURAL GAS COMPANY, a Delaware corporation, whose address is Post Office Box 4289, Farmington, New Mexico, 87499-4289, and MERRION OIL & GAS CORPORATION, whose address is Post Office Box 1017, Farmington, New Mexico 87499.

## WITNESSETH:

WHEREAS, under the provisions of the Act of February 25, 1920, 41 Stat. 437, 30 U.S.C., Secs. 181 et seq., as amended by the Act of August 8, 1946, 60 Stat. 950, the Secretary of the Interior on the 18th day of September, 1953, approved a Unit Agreement for the Canyon Largo Unit area and the Commissioner of Public Lands of the State of New Mexico on June 3, 1953, consented to and approved said Unit Agreement by authority of Chapter 88 of the Laws of the State of New Mexico, 1943, approved April 14, 1943, and the State of New Mexico Oil Conservation Commission on June 2, 1953, approved said Unit Agreement by authority of Act of the Legislature (Chapter 72, Laws 1935), wherein The Superior Oil Company was designated as Unit Operator; and

WHEREAS, The Superior Oil Company has resigned as such Operator and, in accordance with the terms of the Canyon Largo Unit Agreement, El Paso Natural Gas Company was appointed and has accepted and assumed the duties of the successor Unit operator, and

WHEREAS, El Paso Natural Gas Company now desires to appoint Merrion Oil & Gas Corporation as Agent, to perform certain duties under the Canyon Largo Unit and whereas Merrion Oil & Gas Corporation desires to accept and assume the duties of Agent, as set forth below:

NOW THEREFORE, it is mutually agreed as follows:

1. El Paso Natural Gas Company, as Unit Operator under the Canyon Largo Unit Agreement, hereby designates Merrion Oil & Gas Corporation as Agent to drill, complete, operate and/or plug and abandon a water disposal well, the injection zone being the Cliffhouse, Mesaverde formation in the following described portion of the Unit area:

#### Township 24 North, Range 6 West, N.M.P.M.

Section 9: SW/4

Containing 160.00 acres, more or less

- 2. Merrion Oil & Gas Corporation hereby covenants and agrees to comply or secure compliances with all obligations of the Unit Agreement with respect to the above described portion of the Unit area and to file all applications required or necessitated by the terms of such Agreement. Also it is understood that Merrion Oil & Gas Corporation will procure all necessary permits and approvals from the State of New Mexico Oil Conservation Division or any other governmental agencies requiring such approval and to comply with all rules and regulations.
- 3. It is specifically understood that this Designation of Agent does not relieve El Paso Natural Gas Company of its responsibilities as Unit Operator of the Canyon Largo Unit.
- 4. It is specifically understood that the Water Disposal Well shall solely be used for disposal of produced water from unit wells.
- 5. It is further understood and agreed that El Paso Natural Gas
  Company, as Unit Operator of the Canyon Largo Unit area, may, at
  its option, take over operations of the water disposal well and
  revoke this Designation of Agent by giving written notice of such
  revocation to Merrion Oil & Gas Corporation and the Supervisor, Oil
  and Gas Operations, the United States Geological Survey. Upon
  receipt of written notice, Merrion Oil & Gas Corporation agrees to
  turn operations over to El Paso Natural Gas Company, as Unit
  Operator.
