
Dear Mr. Collins,

My staff has reviewed your request to extend the implementation period on the above referenced Division Order. Providing that all conditions contained in the order remain the same and there are no new wells in the area of review since the original permit approval date, the expiration date of the SWD-510 is hereby extended to October 25, 1995.

In the event any drilling activity occurs or has occurred in the subject area of review, Yates Petroleum Corporation will notify the Supervisor of the Artesia District office and the Division office. An administrative review of the permit will be conducted, and the status of the permit will be determined.

All other provisions and conditions of SWD-510 and Division Rules 706 and 1120 shall remain in full force and effect.
