

Dear Sir.

Marathon Oil Company obtained approval to convert the referenced well to SWD 10/28/91 as per the referenced SWD No. 439. The well was not converted and is presently temporarily abandoned. Due to increasing the water associated with our Co Production efforts additional water disposal capacity is urgently needed. Co Production is Marathon's term for artificially lifting large quantities of water to increase gas production.

The well will be completed in the same zone as the original permit but completion method will be different. A well bore diagram with the proposed completion is attached.

A map showing the Area or Review is also attached along. The proposed average and maximum injection rates; are increased to 12,000 BWPD and 15,000 BWPD respectively. The proposed maximum and average injection pressures are 1,000 PSIG and 2,080 PSIG respectively.

Also the original permit included data from the two wells listed below which was not necessary as neither met the conditions of Form 108 as being inside the AOR and penetrating the proposed injection zone. See attached plate showing distance and well TD.


