The above named company is hereby authorized to commingle Sand Dunes-Bone Spring (Oil - 53800) and East Sand Dunes-Delaware (Oil - 53817) Pool production from the following leases:

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: The commingled production shall be measured and stored in the Sharbro Federal Well No. 1 tank battery facility located in the SE/4 SE/4 of Section 7, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico.

FURTHER: The operator shall notify the Hobbs district office of the Division prior to implementation of the commingling process.

PROVIDING: Like approval from the U.S. Bureau of Land Management is also required.
