Gentlemen:

Unocal respectfully requests approval for off-lease storage and measurement for our Federal "G" Well No. 1 located in the SW/4 NE/4 of Sec. 31, Twp. 9S, Rge. 36E, Lea County, New Mexico. The tank batteries will be located in the SE/4 SE/4 of Sec, 31, Twp. 9S, Rge. 36E on our Federal "D" lease. Unocal is requesting this proposal for the purpose of producing Federal "G" which is an economical flowing oil well from the Devonian formation. The off-lease storage and sales at the site of the Federal "D" battery reduces land damages in comparison to erecting a new tank battery on the "G" lease. The surface owner is the same on the "G" and the "D" lease and has agreed to the storage facilities as described.

Federal "G" Well No. 1 is currently producing 57 BOPD (gravity is 43.7 deg @ 60 deg F), a trace of water, and no gas.

Fluids from the Federal "G" will flow from the well down a two-inch flowline to the Federal "D" battery. At this time the well is making oil with just a trace of water, therefore the separation vessel is bypassed. The oil is flowed directly into one of the two tanks dedicated to the Federal "G" production. The Federal "G" production facilities are separate and isolated from the Federal "D" production facilities. Federal "G" oil production and sales is measured by tank gauging methods and the oil is sold by truck, shipped by Pride Oil Company and purchased by Unocal. The Federal "D" Well No. 1, a submersible producing well was shut in on December 28, 1990 to repair the downhole equipment damaged by lightening. On January 7, 1991 after the equipment was repaired the Federal "G" Well No. 1 SWD was back flowed to the Federal "D" No. 1 production battery to reduce the tubing pressure and the well began flowing oil which had carried over during normal production operation.

The Federal "G" Well No. 1 was back flowed to the battery from January 7, 1991 to June 18, 1991. The producing well Federal "D" Well No. 1 was shut in during this time and all of the oil recovered, production reported and royalty paid from this lease until June 18, 1991 was from the Federal "G" Well No. 1.

The Federal "G" Well No. 1 is located in the Unit "G" of Section 31, Township 9 South, Range 36 East, NMPM, West Crossroads-Devonian Pool, Lea County, New Mexico. Please find attached for your reference the corrected monthly regulatory reports. The total oil recovered summary is shown below.
