The aforesaid production is to be transported prior to measurement to its own tank battery to be located in Unit O, Section 26, Township 18 South, Range 25 East on the Babcock "IR" Lease.

NOTE: This installation shall be operated in accordance with the provisions of Rules 309-A and 309-B of the Division Rules and Regulations, and there shall be no intercommunication of the handling, separating, treating, or storage facilities designated to each of the above leases.

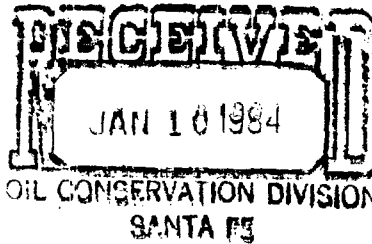

Dear Sir,

Under provisions of NMOCD Rule 309C, Yates Petroleum Corporation seeks administrative approval for an exception to NMOCD 309A, whereby production from our Bonnie "YM" Lease, located in the SE/4, SW/4, Section 26-T18S-R25E, may be transported by pipeline prior to measurement to an individual tank battery located on our Babcock "IR" lease, located in the SW/4, SE/4, Section 26-T18S-R25E.


Both leases concerned have only Yeso, San Andres completions with sour crude and gas production.

1. Commingling of production will not result.
2. There will be no intercommunication of the handling, separating, treating, or storage facilities designated to each lease.
3. Yates Petroleum Corporation is the operator for all leases concerned.
4. Ownership Plats of the leases are attached.

This exception is asked for in order to utilize existing water and gas lines and to lessen the environmental impact with respect to safety, fire hazard, noise and air pollution.
