Following is the "Surface Use and Operation Plan" for the relocation of production facilities on Anadarko's Taylor Fee lease and Carper Federal lease to the Baxter "B" Federal lease.

1. <u>Existing Roads</u> - A map is attached (Exhibit #1) showing the leases concerned on the relocation of the production facilities of the subject leases in relation to Loco Hills Townsite.

A second map (Exhibit #2) shows existing caliche lease roads in blue.

2. <u>Planned Access Roads</u> - This relocation of production facilities will not require any new roads. There will be no fence to cut or cattleguard to set.

3. Location of Existing Wells - All existing wells on these leases are indicated on enclosed maps (Exhibits #1 & #2). There are no exploratory wells being drilled within a two mile radius.

4. Location of Tank Batteries, Production Facilities & Lines - Exhibit #2 shows the present location of the subject rpoduction facilities in Yellow. Proposed relocation of these production facilities are shown in Red. Proposed flowlines in dashed green will be 2" black SDR-11 Dupont 837 PE pipe unrolled on top of the ground and run through 5" conductor pipe beneath lease roads intersected.

5. Location and Type of Water Supply - Not applicable.

6. <u>Source of Construction Material</u> - Not applicable. An existing caliche pad will be utilized for this relocation project.

No Archaeological Study will be required since an existing caliche pad will be used.

7. <u>Methods for Handling Waste Materials</u> - No drilling pits, reserve pits or rubbish pits are required. A small drainage pit with wire mesh over it will be on the site.

8. Ancillary Facilities - There are no camps or air strips planned.

We propose to relocate the production from the Taylor #1, #2 & #3 wells (S/2 SW/4 Unit Letters M & N, Sec. 30, T16S, R32E, Lea County, New Mexico) to the SE/4 SE/4 Unit Letter P, Sec. 25, T16S, R31E, Eddy County, New Mexico.

It is our intention to build a new tank battery @ Unit Letter P, Sec. 25 consisting of four oil storage tanks & four gun barrels. Production on the Baxter Federal "B" lease (NM 041538) and the Carper Federal lease (also NM 041538) will be maintained separately, although Anadarko is currently the sole interest holder. Likewise, production from the Taylor #1 & #2 will be maintained separately from the Taylor #3, although Anadarko is also currently the sole lease holder.

This consolidation is proposed for four reasons:
