Yates Petroleum Corporation respectfully requests administrative approval to commingle production from three wells into a common tank battery and to permit production from each well to be transported prior to measurement to another well for storage thereon. It is proposed to commingle the production from the following wells:

Foster FF #1 1980' FSL and 1980' FEL Section 1-T20S-R24E Eddy County, New Mexico

Foxtail AJX #1 660' FSL and 660' FWL Section 1-T20S-R24E Eddy County, New Mexico NM NM 82097 (A) Foster FF Com #2 1855' FSL and 660' FWL Section 1-T20S-R24E Eddy County, New Mexico NM NM 82097 (A)

The production from the wells will be commingled into a common storage facility located on the Foster FF #2 location. A map labeled Attachment I is enclosed for your information.

The purpose of this off-lease storage and surface commingling is to reduce operating costs for storage and treating and thereby extend the economic life of each well. Without approval for utilizing existing batteries on adjacent leases, it will become necessary to build separate facilities for each well. This will greatly increase costs and shorten the economic life of the well.

Because working interests for the proposed wells are different from the well where the proposed storage facilities are located, oil from each of the wells will be measured by positive displacement, temperature compensated metering equipment prior to surface commingling. Gas from the wells will also be metered separately. This metering will ensure that all production from each of the wells is equitably accounted for

with no significant effect on your revenue. The production in the wells will be from the same producing zone which is the Canyon.
