In regards to the application for surface commingling on the Monterey State "A" and "B" Leases filed on January 9, 1989, please be advised that more information is necessary in order to process the application. Please submit the following information:

- 1. A plat showing the horizontal extent of each of the subject leases.
- 2. A schematic diagram of the proposed commingling facilities including tanks, valves, treaters, etc.
- 3. Proof that the purchaser was notified of the proposed commingling (copy of letter or certified receipt).

Gentlemen:

Southland Royalty Company respectfully requests the Secretary-Director of the New Mexico Oil Conservation Division to approve Lease Commingling for the above captioned leases. Southland Royalty Company has 100% interest in both Monterey State Lease "A" & "B" and request approval to commingle production from Monterey State "A" #4, which is now going to tank battery on Lease "A", with production in tank battery on Lease "B". This well is presently producting 2 barrels of oil a day; therefore, the company does not feel the purchase of a new storage tank would be justified.

I have attached a schematic diagram of the commingling facility. We plan to move the flowline which presently connects Monterey State "A" #4 to Lease "A" tank battery and tee it into the flowline which presently connects Monterey State "B" #1 to Lease "B" tank battery. A port-a-check valve will be used to accurately determine production from each well on a monthly basis.

Southland Royalty Company has respectfully requested waivers of objection from the purchaser(Texas New Mexico Pipeline Co.) by certified mail.
